1. The persons engaged as Guest Faculty will be paid Rs.1000/- per lecture subject to a maximum of Rs.25000/- per month. This engagement shall be valid upto 15th May, 2017.
2. This engagement will be made purely on adhoc basis against the vacant posts of Assistant Professor of the Vidyapeetha as per the guidelines of the UGC.
3. The Guest Faculty shall not be entitled to any other benefit such as Confirmation, LTC, Medical reimbursement, allotment of accommodation, Leave etc. which is admissible to the regular employees of the Vidyapeetha.
4. The Guest Faculty will have no claim for regularisation/seniority on the basis of this engagement.
5. The Vidyapeetha administration reserves the right to terminate this engagement anytime even before the stipulated time.
6. If at any stage it is found that the candidate has submitted fake/wrong documents/certificates/claims or any wrong statement in the application, action may be initiated against him/her as per rules.
7. The Guest Faculty shall be required to perform the teaching and other duties as assigned by the Dean of the faculty and the Vidyapeetha administration which is subject to periodic review.
8. On expiry of the period of this contractual engagement, the Guest Faculty will not be required to turn up for duties unless the contract for further engagement is renewed based on the offer and acceptance.
9. Incomplete applications and applications received after the due date shall be rejected.
