At the outset, the Chairperson and Vice-Chancellor of the University extended a warm welcome to the members present in the meeting and also introduced the newly nominated member- Prof. Prem Kumar Sharma in place of Prof. Piyush Kant Dixit. Subsequently, Dr. Ram Chandra Sharma performed Manglacharan before commencement of the meeting of the Executive Council. The comments of the Ministry of Education, Govt. of India as communicated vide letter No.F.1-1/2022-Skt.I dated 20.03.2024 on the agenda items was circulated amongst the members of the Executive Council and also duly deliberated during the meeting.

Thereafter, Shri Santosh Kumar Srivastava, the Registrar (i/c) of the University presented the agenda items:-

Item No.10.1 To consider the minutes of the 9th (Special) meeting of the Executive Council held on 05.12.2023 for confirmation.

The Executive Council while considering the minutes of 9th (Special) meeting held on 05.12.2023 noted that the said minutes were circulated to the esteemed members of the Executive Council for consideration and/or for comments (if any). It was apprised to the Committee that no discrepancy has been pointed out by any member of the Executive Council, accordingly, the Executive Council *resolved to confirm the minutes of the 9th (Special) meeting, held on 05.12.2023.*

Item No.10.2 To consider and approve the Secretary's Report on the Action Taken on the Minutes of the 9th (Special) meeting of the Executive Council held on 05.12.2023.

As regards, the action taken on Item No.9.2 related to case of Dr Yasmin Ashraf, it was informed that she had joined the service as Assistant Professor at the Regional Institute of Education, NCERT Ajmer, Rajasthan, therefore, the meeting of the Committee constituted to examine the deficiency in her caste certificate could not schedule. The candidate namely- Smt. Shruthy K.V whose name was kept in panel for appointment as Assistant Professor-Sanskrit Shikshan has also not accepted the offer of appointment. Thus, the post will be re-advertised.

Thereafter, the Executive Council *resolved to note the Secretary's Report regarding the action taken on the minutes of the 9th meeting of the Executive Council held on 05.12.2023.*

Item No.10.3.1 To consider and approve the Annual Report for the year 2022-2023 of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi

The Executive Council noted the contents of agenda regarding the Annual Report for the year-2022-2023 of SLBSNSU, New Delhi and *resolved to approve the Annual Report - 2022-2023 of SLBSNSU, New Delhi. It was further resolved to ratify the orders of the Vice-Chancellor under Clause-11 (3) of the Central Sanskrit Universities Act, 2020 for laying the Annual Report -2022-2023 before the both Houses of Parliament and forwarded to the Visitor through the Ministry of Education, Government of India.*

Item No.10.3.2 To consider the report of the High Level Committee dated 26.08.2023 in case of promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader, Associate Professor and Professor under Career Advancement Scheme of the UGC

The Executive Council while considering the report of the High Level Committee noted that in accordance with E.C Resolution No.7.8 dated 30.06.2023, a High Level Committee was constituted to assess the applicability of Clause-8.00 of the UGC notification 1998 and UGC Regulations, 2010 as amended from time to time, in the matter related to promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader, Associate Professor and Professor under Career Advancement Scheme of the UGC. The High Level Committee in its meeting held on 26.08.2023, given the following report/recommendations:

1. The Office of the Director General of Audit (Central Expenditure) in its Inspection Report for the year 2016-22, has raised the Audit Para No-3 (OBS-263060 dated 17.08.2022) regarding promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader/Associate Professor and Professor under Career Advancement Scheme in the Vidyapeetha. The Audit has recommended that the promotion of Dr. A.S. Aravamudan may be made as per clarification of UGC and the salary arrears paid to Dr. A.S. Aravamudan may be reviewed on the basis of his promotion, as per rule.
2. Dr. A. S. Aravamudan had joined the service of the Vidyapeetha as Lecturer (Mimamsa) in the grade of Rs.8000-275-13500 w.e.f. 10.04.2003. Before joining the service of the Vidyapeetha, Dr. A.S Aravamudan was employed at Rajiv Gandhi Kendriya Sanskrit Vidyapeetha, Sringeri under the Rashtriya Sanskrit Sansthan as Lecturer (Rs.8000-13500) w.e.f. 22.10.1997 and Lecturer-Senior Scale (Rs.10000-325-15200) w.e.f. 22.10.2001.
3. In this context, the HLC took note of the entire case file, thereafter agenda note put up to the Executive Council for its consideration in the 7th meeting held on 30.06.2023, as also its direction brought out in the first paragraph of this minutes. The HLC also took cognizance of the extant regulation on the subject, besides the C&AG audit para, while examining the case.

4. The HLC was of the unanimous view that the case has to be dealt with reference to the UGC Notification/Regulation of the subject, and no advisory/instruction issued by the University Grants Commission can be contrary to the law as laid down in the relevant notification/regulation, Clause No.8.0.0 of UGC Notification 1998 stipulates, "previous service, without any break as a Lecturer or equivalent, in a university, college, national laboratory, or other scientific organisations, e.g. CSIR, ICAR, DRDO, UGC, ICSSR, ICHR and as a UGC Research Scientist, should be counted for placement of Lecturer in Senior Scale/Selection Grade." As per the said notification, the past services rendered by Dr. A. S. Aravamudan in the pay scale of Rs.8000-13500 and Rs.10000-15200 at previous organization were countable for placement in the senior scale (Rs.10000-325-15200) and Selection Grade/Reader (i.e. 12000-420-18300), respectively.
5. Accordingly, the Committee recommended that the promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader, Associate Professor and Professor has just been effected by the University, in terms of the existing Career Advancement Scheme of the University Grants Commission.

After going through the above-mentioned report, the Executive Council observed that the appointment, promotion of the teaching staff of the Universities under CAS and counting of past services for the purpose of promotion/direct recruitment is governed only by the UGC Notification/Regulations as amended from time to time. No other provisions/rules can be enforced in such matters in the University. The past services of the incumbent concerned rendered as Lecturer in the pay scale of Rs.8000-13500 and Rs.10000-15200 at previous organization were countable for placement in the senior scale (Rs.10000-325-15200) and Selection Grade/Reader (i.e.12000-420-18300) under Clause No.8.0.0 of UGC Notification 1998. Therefore, the promotion of Dr. A. S. Aravamudan as Lecturer-Senior Scale, Reader, Associate Professor and Professor is in conformity with the guidelines/ provisions of UGC Notification, 1998 and UGC's Regulations, 2010 as amended from time to time. But, it is not clear under what provision of the UGC Notification/Regulations, the UGC has not taken into account its own guidelines related to counting of past services in case of Dr.A.S.Aravamudan. In this matter, the Ministry of Education vide letter dated 30.06.2023 had given the following observations on the agenda of the 7th meeting of the EC held on 30.06.2023:-

"As per the normal procedure past services rendered without any break will be counted for all benefits and the date of initial appointment will be from the date of initial appointment irrespective of any mode. In support of this, there are several court orders. However, as the University has taken a suo moto action in providing relief to this person, it is suggested that the University may take up the matter with the UGC and seek clarification whether they have taken into consideration the provisions contained under clause 8.00 of their 1998 notification before conveying their clarifications vide their letters dated 31.03.2016 and 01.04.2016"

Executive Committee also noted that UGC has provided two affirmative comments on the same matter and on the third occasion, the UGC comment was not affirmative. After going through the entire position of the case, *the Executive Council resolved that the matter be consulted with the UGC through Language Division of Ministry of Education that under which provision of the UGC Notification/ Regulations, the case of Dr.A.S. Aravamudan for counting of past services was not accepted while communicating the clarification vide its letter dated 31.03.2016 and 01.04.2016. Whether the provisions contained under Clause-8.00 of their Notification, 1998 were taken into account before conveying their clarification vide letters dated 31.03.2016 and 01.04.2016*

Item No.10.3.3 To consider the placement of Faculty from the Academic Pay Level-12 to Level-13A and Level 13A to Level 14 under the Career Advancement Scheme.

The Executive Council noted that the matter related to placement of teachers from the Academic Pay Level-12 to Pay Level-13A and Level-13A to Level-14 was placed before the Executive Council at its 7th meeting held on 30.06.2023 wherein it was resolved that the Vice-Chancellor be authorized to constitute an Expert Committee to consider the matter and submit its recommendations to the Executive Council for an appropriate decision, at the earliest. Subsequently, the Vice Chancellor constituted an Expert Committee to examine the case and to submit its recommendation.

The duly constituted Committee met on 11.08.2023 and after detailed deliberation, the Committee was of the view that "since prior to the UGC Regulation of 2018, there was no distinction in the eligibility criteria for the faculty members for promotion under CAS, either in the colleges or in the university system, it would be patently unfair to discriminate such faculty members by debarring them from CAS which accrues to a faculty in the college system. It was none of their fault that they could not conduct/oversee Ph.D, programme as the deemed University or the National Sanskrit University did not have such programmes during the relevant period when these faculty members became eligible for consideration under CAS due to the fact that they have already completed the required number of years, besides fulfilling the other necessary eligibility criteria."

The Committee also took a note of the fact that the Executive Council of Shri Lal Bahadur Shastri National Sanskrit University has taken cognizance of the peculiar conditions obtaining in respect of such faculty members." Further, the Committee in its conclusion stated that "the Expert Committee is of the considered view that in deviation of the extant UGC guidelines on the subject, the university may consider such faculty members eligible for grant of CAS. The Committee is conscious of the view that this approach was being recommended only to avoid undue hardship to the faculty members for no fault of theirs. This, however, may not be taken as precedent in other cases unless identical situation are met with. The Committee is sure that in course of time

any such eventuality will not be there as the university, in its development phase is bound to start more and more PG and Ph.D. programmes."

The aforesaid recommendation of the Committee were placed before the 8th Executive Council in its meeting held on 16.08.2023. The Executive Council after due consideration, resolved to accept the recommendation given by the Expert Committee in its report dated 11.8.2023. The Executive Council also advised the University to forward the same to UGC for concurrence.

Thereafter, the matter was referred to UGC vide letter dated 22/09/2023 for their concurrence. In response to that UGC vide its letter No.F.9.1/203 (PS/Misc.) dated 30th October, 2023 again reiterated the clause 6.4 (C) (iii) of UGC Regulation 2018 for promotion to the post of Associate Professor and also refer the 3rd Amendment of UGC Regulation 2023.

As stated above, the report of Expert Committee dated 11.08.2023 has already been accepted by the Executive Council but no clarification on the matter and/or decision of the Executive Council has been communicated by the UGC except referring Clause-6.4(iii) of the UGC Regulation 2018. During the meeting, there was a view of most the members to consider the promotion under CAS at par with the Clause-6.4 (I) (B) (I) which is applicable for college teachers to avoid undue hardship of the faculty member as a special case and such decision will not be taken as precedent in any other future case. However, the representatives of Joint Secretary (Language), Ministry of Education have given their view that the matter be again taken up with the UGC for relaxation.

After detailed discussion, *the Executive Council resolved to again refer the case to the UGC through Language Division of Ministry of Education for necessary relaxation in Clause No.6.4 (C) (III) of the UGC Regulations, 2018 at par with other higher educational institutions.*


Item No.10.3.4 To report the status of backlog vacancies of SLBSNSU, New Delhi


The Executive Council was apprised about contents of the agenda note relating to issue advertisements of the teaching and non-teaching posts vide Advt. No.02/2022, 04/2022 and 02/2023 and the follow up action taken by the University. The Executive Council noted the status of backlog/reserved positions of the University.

Item No.10.3.5 To report the constitution of High Powered Committee to conduct a preliminary fact finding inquiry on the allegations leveled in the complaints of Prof. Yashveer Singh and Prof. Devendra Prasad Mishra against each other.

The Executive Council noted that the cross-complaints dated 01.01.2024, 02.01.2024 and dated 08.01.2024 were lodged by Prof. Yashveer Singh of Department of Dharamshastra and Prof. Devendra Prasad Mishra of Department of Veda respectively, leveling varied allegations against each other.

Thereafter, the Vice-Chancellor vide Orders dated 08.01.2023 as advised by the Committee of Deans of School of Studies, constituted a High Powered Committee under the Chairmanship of former Judge of Allahabad High Court,

Justice Dr. Satish Chandra, Shri Bhavnesht Saini, Judicial member (Retd.), ITAT (Special Secretary to Govt. of India); and Shri K.S Mahajan, Under Secretary to the Govt. of India (Retd.) to conduct a preliminary fact finding inquiry on the allegations leveled in the complaints, referred above. The constituted High Powered Committee was requested to submit its report to the Vice-Chancellor of the University with its findings on the veracity and gravity of the allegations and counter allegations for consideration of the Executive Council, at the earliest.

The above-mentioned action has been taken by the Vice-Chancellor to maintain the discipline in the University under Clause-3(4) of the Statutes of the University. As per the afore-cited Clause, the Vice-Chancellor shall have all the powers necessary for the proper maintenance of discipline in the University and he may delegate any such powers to such person or persons, as he deems fit.

The Executive Council was apprised the contents of the complaints dated 01.01.2024, 02.01.2024 and dated 08.01.2024 as mentioned above along with the recommendation of Deans of School of Studies dated 04.01.2024, 10.01.2024 and the other relevant letters received from both the complainants.

The Chairman of the Executive Council explained the reason for engagement of a retired judge as Chairman in the High Powered Committee and present status of preliminary enquiry. After going through the above-mentioned position, *the Executive Council being the Appointing Authority of teaching staff under Clause-20 (1) of the Statutes of the University, resolved to ratify the Orders of the Vice-Chancellor dated 08.01.2024 related to constitution of High Powered Committee under Clause-3(4) of the Statutes of the University. It was further resolved to place the report of the High Powered Committee before Executive Council, at the earliest.*

The Executive Council considered the minutes of the 7th meeting of the Finance Committee held on 01.12.2023 and *resolved to approve the minutes in toto.*

Item No.10.4.2 To consider the minutes of the Committee dated 13.06.2023 regarding the up-gradation of post of Dr. Gyandhar Pathak, Research Assistant as Assistant Professor in Academic Pay Level-10

The Executive Council noted the contents of the agenda note along with the minutes of the Committee dated 13.06.2023 relating to up-gradation of post of Dr. Gyandhar Pathak, Research Assistant as Professor in Academic Pay Level-10.

The Executive Council observed that the rules and procedure applied for up-gradation of the Research Assistants of the Central Sanskrit University, New Delhi (Rashtriya Sanskrit Sansthan) by the Ministry of Education may be applied for the similar cadre post of this University.

Earlier, the three institutions i.e. Rashtriya Sanskrit Sansthan, New Delhi, Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi and Rashtriya Sanskrit Vidyapeetha, Tirupati were functioning as Deemed to be Universities and the similar rules/regulations were applicable for all these institutions. Accordingly, the case of Dr. Gyandhar Pathak can be settled at par with the Research Assistant of Rashtriya Sanskrit Sansthan and his pay scale can be rationalized/ upgraded from the Pay Level-06 to Pay Level-10.

The Ministry of Education vide their office letter No.F.1-1/2022-Skt.I dated 20.03.2024 has advised to refer the case to the Ministry with a consolidated proposal along with full justification for seeking the approval of UGC/Department of Education (DoE).

In view of the above, the Executive Council resolved that a consolidated proposal with justification be forwarded to the Ministry of Education, Govt. of India at par with the sister institution i.e. Central Sanskrit University, (erstwhile Rashtriya Sanskrit Sansthan), New Delhi, for consideration.

Item No.10.4.3 To consider the minutes of the Committee dated 01.11.2023 regarding norms relating to grant of Compensatory Leave to the Teaching and Group-A officers of the University

The Executive Council considered the minutes of the Committee dated 01.11.2023 regarding implementation of norms relating to grant of Compensatory Leave to the Teaching and Group-A officers of the University. The Executive Council observed that in the Government of India rules, there is no provision for granting compensatory leave to Group-A officers. Further, in the UGC Regulations, 2018, no such provision has been prescribed for grant of compensatory leave to the teaching and other academic staff of the Universities. As per the advice of the Joint Secretary, Ministry of Education duly communicated vide letter No.1-1/2022-Skt.I dated 20.03.2024, the Government of India/UGC rules/instructions needs to be strictly followed and no departure should be there in case of Group-A Officers. After careful consideration, *it was resolved to allow the compensatory leave to Group-"B & "C" (Non-Gazetted) - non-teaching employees only, as per the norms of Govt. of India and the guidelines as prescribed by the Committee for availing such kind of leave by the office staff of the University.*

Item No.104.4 To consider and approve the minutes of the Committee of Deans of School of Studies dated 01.02.2024 regarding (i) establishment of "Swami Shri Karpatri School of Studies and Research" and (ii) to start the study and research work of "Shri Swami Narayan Vedanta" under School of Study of Darshan of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi.

The Executive Council considered the proposals as recommended by Committee of Deans of School of Studies and Vice-Chancellor of SLBSNSU, New Delhi on 01.02.2024 as under:-

- (i) establishment of "Swami Shri Karpatri School of Studies and Research" and
- (ii) to start the study and research work of "Shri Swami Narayan Vedanta" under School of Studies of Darshan

(i) It was informed that the proposal related to establishment of "Swami Shri Karpatri School of Studies and Research" has already been approved by the Executive Council through circulation. Regarding the creation of posts under the Swami Shri Karpatri School of Studies and Research, the Ministry of Education, Govt. of India vide their office letter No.1-2/2024-Skt.I dated 14.03.2024 has requested to prepare separate checklists for each category of the posts as per Department of Expenditure's OM dated 04.01.2024 and resubmit the proposal along with justification to the Ministry.

(ii) As regards the establishment of "Shri Swami Narayan Vedanta" under School of Studies of Darshan, it has been proposed by Shri Swami Narayan Mandir Vadltap Sansthan, Gujarat. To consider the proposal regarding extension of hostel facility to the students of SLBSNSU, New Delhi

The Executive Council was informed that Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU), stands as a beacon of Shastraic tradition, higher learning, and the interpretation of Shastras. SLBSNSU comprises five schools, each contributing to the academic vision of the University. The School of Veda-Vedanga, School of Darshan, School of Sahitya and Sanskriti, School of Education, and School of Adhunik Vidya provide a comprehensive platform for the study of traditional Shastra disciplines, teacher training programs, and advanced courses in Shiksha Shastra. Presently, there are 1637 regular and 400 part time students are studying in the University and there is only one hostel available in the campus having capacity of 100 students only. This hostel is being allotted to boys students since long and there is no accommodation available for girls students in the campus (as girls hostel). During the past, it was noted that enrollment of girls students in the various courses of the University is very less and sometime girls students are migrating even after

taking admission in some of Shastri (Sanskrit) courses. Most of the students studying in the University, belongs to normal/poor background and generally not capable to afford the high cost of living at Delhi.

The Hon'ble President of India in Her convocation addressed during the first convocation of the University held on 05.12.2023 mentioned that "मैं समझती हूँ कि वेद-वेदांग का अध्ययन, अध्यापन करने वाले इस संस्थान में गार्गी, मैत्रेयी, अपाला, रोमशा, लोपामुद्रा और मंडन मिश्र की भार्या उभय भारती जैसी विदुषी महिलाओं के विषय में जानकारी मिले और सम्मान भी। इसलिए मैं चाहूँगी कि इस विश्वविद्यालय में छात्राओं को और अधिक प्रोत्साहन मिले तथा उन्हें अपनी प्रतिभा का प्रदर्शन करने के पर्याप्त अवसर मिलें।"

This University is spread over an area of 10.65 acres and there is very less possibility to create/construct hostel to cater such immediate need. Keeping in view of the above, the University is proposing to hire hostel facilities at nearby areas for 100 to 200 students.

After detailed deliberations in the matter, the Executive Council resolved to accept the proposal of the University for hiring/outsourcing hostel facilities for university students. The matter be reported to the Academic Council at its next meeting for information.
