To consider and approve the duly filled form of the Vidyapeetha for consideration under HEFA scheme of the Ministry of Human Resource Development, Govt. of India.

The Finance Committee perused the letter No. F.No.1-4/2018-Skt.I cated 01.01 2019 Department of Higher Education, Ministry of Human Resource Development, Govt. of India regarding approval of 04 projects to Shri Lal Bahadur Shastn Rashtnya Sanskrit Vidyapeetha for funding on loan basis through Higher Education Funding Agency (HEFA), total sanction is of Rs. 68.17 crore. The Chairman expressed his concern about the repayment of the principal component and interest amount by the Vidyapeetha in the light of the limited possibilities of generation of Internal revenue. The Finance Committee observed that the Ministry while sanctioning the loan to the Vidyapeetha had written the following comments with respect to repayment of principal and interest possibilities of generation of internal revenues by the SLBSRSV, the above provisions in case of SLBSRSV would be made applicable only after due joint review by the Department of Higher Education and the Department of The Finance Committee advised that the Expenditure^{*}. Vidyapeetha should fill up and submit the requisite formats as per the letter of Ministry of HRD.

Further, the Chairman suggested that a separate proposal for construction of multipurpose building, consisting of 4 floors at the initial stage but extendable upto 10 floors subject to approval and availability of funds, may be submitted to University Grants Commission for sanction of funds. The Finance Committee agreed with the proposal and advised to submit the proposal to University Grants Commission. Further since the HEFA forms and financials are to be submitted in a time bound manner, this item may be treated as confirmed on the table itself.

Item No. 14.6

To consider the purchase of new Car consequent upon the disposal of the existing diesel vehicle.



The Finance Committee examined the proposal for replacement of the existing innova car which has been declared as condemned as per the certificate of Alroot Authority of India. The Finance Committee observed that the replacement of vehicle should be done as per the extant rules in this regard. The Secretary informed the Committee that after the condemnation of Innova car, only two cars will be left in the Vidyapeetha which are earmarked for Vice-Chancellor and Registrar.
