It was apprised to the Committee that no discrepancy has been pointed out by any of the member of the Executive Council. However, in respect of Item No. 14.5.3. the MoE vide its letter No. 1-1/2022-Skt.I dated 15.10.2025. mentioned the following:</p> <p><i>"Lien is retained by a permanent Government employee (GE) for a period on 2 years. It is extendable upto 3 years in exceptional cases. However, while considering termination of lien of GE, it is to be ensured that he is not left without a lien on permanent post."</i></p> <p><i>Accordingly, it is clarified that since Prof. Mishra's appointment as Vice-Chancellor is against a tenure post, he will be accommodated against his substantive post in his parent office on completion of his tenure in his present post. As such, the term lien cannot be used in this context and accordingly the contents in this agenda point be modified accordingly".</i></p> <p>Accordingly, after detailed deliberations, the Executive Council advised that the term "four years lien" be deleted from the relevant records. It was further decided that the officer concerned shall be repatriated to his parent post upon completion of his tenure or before, as per rule.</p> <p>The Executive Council resolved to confirm the minutes of the 14th meeting, held on 26.08.2025, as per above modification.</p>

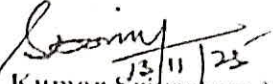
