## To consider and approve the Annual Accounts 2021-2022 of Shri Lal Bahadur Shastri National Sanskrit University.

The Annual Accounts 2021-2022 of Shri Lal Bahadur Shastri National Sanskrit Universitywere presented before the Finance Committee. The Finance Committee noted that Annual Accounts have been prepared as per the New Accounting Format and necessary provisions for retirement benefits according to AS-15 have also been made. The comments of IFD on the item were also perused. After a detailed discussion, the Finance Committee Resolved to approve the Annual Accounts 2021-2022 of Shri Lal Bahadur Shastri National Sanskrit University. Further as the Annual Accounts are to be submitted to the Audit Office within a scheduled timeframe, the Finance Committee Resolved to appreve the item as table confirmation item.

## To consider and approve the writing off the mutilated/damaged/worn out books in the Central Library of the University.

The proposal was discussed by the Finance Committee in the light of the Library Physical Verification reports for the year 2013 and 2017 annexed with the agenda item. The Finance Committee noted that the proposal for writing off the 2850 nos. of books does not fall under preview of Rule 215 of GFR, 2017 as these are not missing books. The Finance Committee was also informed that these books are not in a usable condition and have been kept separately. The Finance Committee opined that the books should not be of rare nature and should not have been mutilated/damaged/worn out due to lack of proper upkeepment/custody and carelessness on the part of the staff members. It was assured to the Committee that these books have been mutilated/damaged/worn out due to being very old and the books in question are not rare books.

Accordingly, in the light of the explanation offered and keeping in view the non-usage of these books, the Finance Committee Resolved to approve the writing off 2850 nos. of mutilated/damaged/worn out books valuing Rs. 1,01,407/-.

To report the implementation of enhance rate of Dearness Allowance (from 31% to 34%) to the regular employees and pensioners of the University.
