Prof. Ramesh Kumar Pandey, Vice-Chancellor recused himself from the discussion and decision making process as he is one of the applicants for grant of HAG scale. Consequently, Prof. Kapil Kumar chaired the meeting in respect of the agenda Item No.21.8.

Item No. 21.8 To consider the matter relating to grant of HAG scale of Rs. 67000-79000 to the Professors of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi.

The Board of Management considered the matter relating to grant of HAG scale of Rs. 67000-79000 to the Professors of the Vidyapeetha. The BoM noted that the selection process is to be conducted by the university as per the UGC's Regulations, 2010 through an Expert Committee for evaluation of all credentials submitted by the eligible Professors. Since the modalities with regard to referral procedure, process of

review, constitution of the expert committee and the number of the members to be nominated by the BoM for institution of the Committee, was not stipulated in the UGC's Regulations, 2010, the cases were not processed for want of clarification from the UGC. However, such clarifications as sought by the Vidyapeetha have been given by the UGC in its Regulations, 2018, thus, the pending cases can be considered and processed for grant of HAG scale to the eligible Professors. After careful consideration, *the Board of Management resolved to nominate the following subject experts as referees for evaluation of performance and the credentials by referral procedure as per the UGC Regulations, 2010:-*





The Chairperson extended a warm welcome to the members present in the meeting. Prof. Patanjali Mishra performed Vaidic Managlacharan before commencement of the meeting of the BoM. Subsequently, the following agenda items were taken up for consideration:

- Item No. 21.1 To consider the minutes of the 20th meeting of the Board of Management held on 29.05.2018 for confirmation.**

The Board of Management considered the minutes of its 20th meeting held on 29.05.2018. The BoM noted that the minutes of the 20th meeting of the Board of Management held on 29.05.2018 were circulated to the esteemed members of the BoM to point out discrepancies, if any, within fifteen days from the date of issue of the letter No. LBSV/REG/123/BoM-20/2018/277 dated 01.06.2018. The comments given by the nominee of Joint Secretary (IFD) in respect of Item No.19.7 and 19.8 were thoroughly discussed and decisions thereon were recorded in the minutes of the 20th meeting of the BoM. However, no discrepancy in the minutes was pointed out by any of the esteemed members within the specified time period. Consequently, action on the minutes was taken by the Vidyapeetha. However, the nominee of the Joint Secretary-IFD has forwarded their views by email dated 14th September, 2018 in respect of Item No.19.7 and 19.8, much after the stipulated time. Since the action has already been taken, *the BoM resolved to confirm the minutes of the 20th meeting held on 29.05.2018 without any amendment.*

- Item No.21.2 To consider and adopt the Secretary's Report regarding the action taken on the minutes of the 20th meeting held on 29.05.2018.**

The Board of Management *resolved to note the Secretary's Report on the action taken on the 20th meeting of the Board of Management held on 29.05.2018 as this is in consonance with the rules of the MoA and UGC guidelines. It was further resolved to approve the list of the external experts of modern subjects as updated by Prof. Arvind Kumar Joshi for the Screening Committees and Selection Committees in respect of teaching posts of the Vidyapeetha.*

- Item No. 21.5** To report the UGC's letter No.F.1-1/2012 (PS) Pt.I dated 05.07.2018 relating to placement of Dr. Manoj Kumar Meena, Assistant Professor (Physical Education) in the higher AGP from Rs. 6000/- to Rs. 7000/- under the Career Advancement Scheme of the UGC.

The Board of Management noted the contents of the letter No.F.1-1/2012(PS) Pt.I dated 05.07.2018 of the UGC along with the recommendations of the Screening-cum-Evaluation Committees dated 26.02.2018 and 16.09.2018 regarding the placement of Dr. Manoj Kumar Meena, Assistant Professor (Physical Education) in the higher AGP under the CAS of the UGC. The BoM observed that Dr. Manoj Kumar Meena has the prescribed API score and fulfils all the eligibility criteria for placement in the higher AGPs. The Board of Management considered the case of Dr. Adesh Kumar, Assistant Professor (Computer Science) regarding allotment of average scores of the APIs based on the performance before proceeding on study leave keeping in view the Public Notice No. 9-1/20109 (PS)/(Misc.) dated 5.9.2018 issued by the UGC. The Board of Management observed that for the purpose of calculating API score all such periods of duration which have been spent by a teacher on different kind of paid leaves including Study Leave shall be excluded from the grading assessment. Since Dr. Adesh Kumar was on Study Leave for pursuing his Ph.D from 15.07.2014 to 13.07.2016 with prior approval of the Board of Management, his API shall be assessed for the remaining period of the assessment. Based on the Public Notice dated 5.9.2018 of the UGC, the meetings of the Screening-cum-Evaluation Committee and Selection Committee have been convened by the Vice-Chancellor on 16.09.2018. After careful consideration, the BoM *resolved that the recommendations of the Screening-cum-Evaluation Committee and Selection Committee be approved as these are in consonance with the UGC guidelines:-*

- Item No. 21.8** To consider the matter relating to grant of HAG scale of Rs. 67000-79000 to the Professors of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi.

Prof. Ramesh Kumar Pandey, Vice-Chancellor recused himself from the discussion and decision making process as he is one of the applicants for grant of HAG scale. Consequently, Prof. Kapil Kumar chaired the meeting in respect of the agenda Item No.21.8. *Being confidential recorded separately.*

- Item No. 21.9** To consider revised Bye-Laws Governing the Method of Recruitment - 2018 of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi.

The Board of Management considered the revised Bye-Laws Governing the Method of Recruitment -2018 of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi. Prof. D.P.S. Verma informed that there are some typographical mistakes as well as need of some amendments in policy matter relating to the appointing authority in respect of Group 'C' posts and the maximum age limit for appointment of the Registrar, Finance Officer and Controller of Examination. Consequently, the Board of Management agreed with his proposal. After careful consideration, *the Board of Management resolved to initiate further action on the revised Bye-Laws Governing the Method of Recruitment, 2018 as under:-*

1. The appointing Authority in respect of Group 'C' posts shall be the Vice-Chancellor instead Registrar.

2. In the absence of any specific guidelines of the UGC, the maximum age limit for appointment of Registrar of the Vidyapeetha shall be prescribed as 57 years instead preferably below 57 years.

The Board of Management further authorized Prof. D.P.S. Verma to finalize the final draft Bye-Laws Governing the Method of Recruitment -2018 as early as possible. After making necessary corrections/amendments, the revised draft Bye-Laws Governing the Method of Recruitment -2018 be submitted to the UGC for approval.

- Item No. 21.10** To consider the report dated 11.09.2018 of the Expert Committee relating to review of promotion of Dr. Dev Dutt Chaturvedi and Dr. (Mrs.) Rashmi Mishra as Professor (Sahitya) under the Career Advancement Scheme of the UGC.

The Board of Management considered the clarification given by the UGC vide letter No.F.3-87/2009(PS), dated 15.03.2018 followed by the report dated 11.09.2018 of the Expert Committee relating to review of promotion of Dr. Dev Dutt Chaturvedi and Dr.(Mrs.) Rashmi Mishra as Professor (Sahitya) under the Career Advancement Scheme of the UGC. After detailed discussion and careful consideration, the BoM *resolved that the report of the Expert Committee dated 11.09.2018 be accepted and promotion of Dr. Dev Dutt Chaturvedi and Dr. (Mrs.) Rashmi Mishra as Professor (Sahitya) under the Career Advancement Scheme be regulated as under:-*

(i) *Dr. Dev Dutt Chaturvedi's promotion from Associate Professor to Professor be treated in order with effect from 30.06.2012, in accordance with the UGC Regulations, 2000.*

(ii) *Since, Dr. Rashmi Mishra met the API requirements in 2012-2013, her promotion from Associate Professor to Professor with effect from 31.12.2012, be treated in order and her request for her promotion with effect from 05.09.2009 not be entertained.*

It was further resolved to confirm the decisions for implementation.

Item No. 21.11 To consider the UGC's letters No.s 7-4/2016 (CU) dated 14.08.2018 and 7-4/2016 (CU) dated 21.08.2018 regarding action on the report of the Inquiry Committee pertaining to appointment of Dr. Sadan Singh and Dr. Yashveer Singh

The Board of Management noted the contents of Agenda Note and consequently considered the Reports dated 27.03.2016 and 22.05.2016 of the Inquiry Committee along with the opinion of the UGC duly communicated vide letter Nos. F.7-4/2016 (DU) dated 04.11.2016, No 7-4/2016 (CU) dated 14.08.2018 and No. 7-4/2016 (CU) dated 21.08.2018 with regard to the legality of the appointment of Dr. Sadan Singh and Dr. Yashveer Singh.

After careful consideration and detailed discussion, the Board of Management being the Competent Disciplinary Authority under Rule-4-4.8 of the MoA read with Clause-4.4 (viii) of the UGC (Institutions Deemed to be Universities) Regulations, 2016 resolved to accept the Report (s) dated 27.03.2016 and 22.05.2016 of the Inquiry Committee in respect of Dr. Sadan Singh and Dr. Yashveer Singh respectively based on the opinion of the UGC as referred above.

Consequently, it was further resolved that Dr. Sadan Singh, Associate Professor(Education) and Dr. Yashveer Singh, Associate Professor(Dharmashastra) be exonerated of all the charges as framed against them as per their respective charge-sheet. The decision of the Board of Management be communicated to the Standing Counsel of the Vidyapeetha and all concerned teachers at the earliest.

Since the recommendations of the above-mentioned teachers were under sealed cover before initiation of disciplinary proceedings, the Board of Management further resolved to open the sealed envelops. Accordingly, the sealed envelops opened and the recommendations of the Screening-cum-Evaluation Committees dated 23.07.2015 & 24.07.2015 and the Selection Committees dated 04.08.2015 & 25.08.2015 relating to their promotion under the Career Advancement Scheme of the UGC as detailed below approved for implementation:
