The Board of Management ratified the Orders of the Vice-Chancellor of the Vidyapeetha as under:-

i	Orders dated 09.05.2019 of the Vice-Chancellor regarding issue of advertisement No.1/2019 relating to recruitment on the teaching posts of the Vidyapeetha as per revised reservation roster and initiation of selection process as per the directive of M/o.HRD
ii	Orders dated 29.07.2019 of the Vice-Chancellor relating to appointment of the 13 candidates against the Group"B" and "C" Non-Teaching posts through open advertisement No.3/2018 as per the Bye-Laws of the Vidyapeetha
iii	Issue of Notification dated 20.02.2019 relating to UGC (Institutions Deemed to be Universities) Regulations, 2019 by the UGC for adoption in the Vidyapeetha.

Item No. 22.7- Any other item with the permission of the Chair.

(i) To consider and decide the matter relating to initiation of selection process where less number of applications are received against the advertisement of the Vidyapeetha.

It was informed to the Board of Management that the teaching posts were advertised by the Vidyapeetha vide Advt. No.01/2019 and in case of some teaching posts, the number of applications received for the posts are less than 03. As per practice, where the number of the candidates are less than 3, the post is re-advertised by the Vidyapeetha. The UGC regulation is silient on this issue. The Ministry of HRD, Govt. of India has already directed the Vidyapeetha to fill-up all the vacant teaching and non-teaching posts on priority basis. Under these circumstances, the Board of Management was requested to advice whether the Vidyapeetha Administration can proceed for selection process in respect of Teaching and Non-Teaching posts if there are eligible/qualified candidates are 1 or 2 for interview who appear for the posts advertised through Newspapers and Websites.

The Board of Management observed that in the absence of any specific rules/guidelines, the minimum ratio i.e. 1:3 for interview cannot not be imposed in case of rare teaching subjects of Sanskrit traditional stream of the Vidyapeetha. Subsequently, the Board of Management resolved that the minimum ratio i.e. 1:3 be not insisted upon the rare subjects of Sanskrit traditional stream and the posts where number of applications are less than 3 (2 or 1) be filled-up subject to fulfilment of eligibility criteria by the candidate concerned as per the UGC Regulations as amended from time to time.
