## (i)

To report the matter related to non-issue of appointment letter to Dr. Tanmay Mandal for the post of Assistant Professor (Education).

The Executive Council was apprised that in accordance with the resolution No.11.4.4 dated 26.06.2024, the process was initiated to utilise the panel for appointment on the post of Assistant Professor (Education). However, the appointment letter could not be issued to the candidate in panel - Dr. Tanmay Mandal, as some deficiency in the field of specialization, related to the eligibility was found by the Committee of the Department of Education vide its report dated 28.08.2024. In this regard, the council members were informed that as on the closing date of advertisement No.02/2022, the candidate in panel (Dr. Tanmay Mandal) was not posessing the required Master's degree in the field of specialization i.e. Environment Education, for the post. At that point of time, he was pursuing the post-graduation degree course in Environment Science. Since the

candidate in panel was not fulfilling the eligibility criteria as prescribed in the Advt. No.02/2022, the Executive Council ratified the action of the University and resolved to re-advertise the post, at an earliest.
