All the members attended the meeting physically except representative of Joint Secretary, who attended the meeting through online.

At the outset, the Chairperson and Vice-Chancellor of the University extended a warm welcome to the members present in the meeting. The Vice-Chancellor also apprised the Executive Council that the Peer Team of the National Assessment and Accreditation Council (NAAC) (consisting of a Chairman, one Co-ordinator, 5 members and one Co-coordinator) has visited the University from 28th to 30th May, 2025 in hybrid mode. After the aforesaid visit & assessment, SLBSNS University accredited with highest ranking of A++ with overall score of 3.55 by the National Assessment & Accreditation Council. Vice-Chancellor also mentioned that it was the first NAAC assessment of this University, after becoming Central University and extended heartest thanks to Govt. of India and its honourable Prime Minister Shri Narendra Modi ji for the kind concern to grant the status of Central University to this University.

Prof. Shitla Prasad Shukla performed Manglacharan before commencement of the meeting of the Executive Council. Thereafter, Shri Santosh Kumar Srivastava, the Registrar (i/c) of the University presented the agenda items:-



Item No.13.1 To consider the minutes of the 12th meeting of the Executive Council held on 17.12.2024 for confirmation.

The Executive Council while considering the minutes of 12th meeting held on 17.12.2024 noted that the said minutes were duly circulated to the esteemed members of the Executive Council for consideration and/or for comments (if any). It was apprised to the Committee that no discrepancy has been pointed out by any of the member of the Executive Council. However, in respect of Item No. 12.5.(i), the MoE vide its letter No.1-1/2022-Skt.I dated 31.03.2025 requested to examine the issue in terms of the provisions contained under Statutes 20(5) of Central Sanskrit Universities Act, 2020 and take action accordingly under intimation to the Ministry. The Executive Council gone through Clause 20(5) of the Statutes of Central Sanskrit Universities Act, 2025, which is reproduced hereunder:

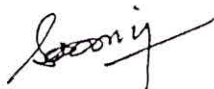
"If the Executive Council is unable to accept the recommendations made by the Selection Committee, it shall record its reasons and submit the case to the Visitor for final orders."

The Executive Council noted that in the instant case, the recommendation of the Selection Committee dated 09.08.2023 related to the post of Assistant Professor (Education Environment) has already been approved by the Executive Council vide Resolution No.8.3 dated 16.08.2023 and also confirmed on table for implementation. After accepting the recommendation of the Selection Committee dated 09.08.2023, Dr. Prabir Bera was appointed as Assistant Professor, Academic Pay Level-10 (under SC category). While taking the decision of termination of service of Dr. Prabir Bera, the Executive Council vide Resolution No.11.4.4 advised to explore the panel within its validity period, for appointment on the post of Assistant Professor (Education Environment), at the earliest. It was further resolved to confirm the decision on the table for implementation.

As per the decision, the pannel was explored and the offer of appointment was duly issued to Dr. Tanmnay Mandal, the first wait listed candidate. However before issuing the formal apointment letter, the administration section examined the original certificates and found that Dr. Tanmay Mandal did not meet the eligibility criteria mentioned in Advertisement 02/2022. Thus, after issuing the offer of appointment, the Appointment Letter could not be issued to him by the University, keeping in view the terms and conditions of offer of appointment and his ineligibility for the post.

As per the position explained in the agenda note, it was clarified that when the recommendation of the Selection Committee has duly been accepted/confirmed by the Executive Council for implementation, the Clause-20 (5) of the Statutes of CSU Act, 2020 need not to be invoked, in the instant case.

Further, the comments of Ministry of Education about the report of the Internal Complaint Committee has been placed as a separate agenda vite Item No.13.4.4.



After going through the above-mentioned positions, Executive Council resolved to confirm the minutes of the 12th meeting held on 17.12.2024.

Item No.13.3.1

To report the DO letter No.A.44011/14/2024-EI dated 19.09.2024 of Secretary, HE duly forwarded by the Ministry of Education, Department of Higher Education received vide email dated 03.01.2025 regarding periodic Review of Central Government Employees for strengthening of administration.

The Executive Council noted the contents of letter No.A.44011/14/2024-EI dated 19.09.2024 of the Ministry of Education along with the Office Memorandum No.25013/01/2024-Pers.Policy A-IV dated 27.06.2024 & No. 31011/14/2023-A.IV dated 03.04.2024 of the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training (DoPT), Govt. of India related to periodic review of employees for strengthening of administration under Fundamental Rule (FR) -56 (j)/(I) and Rule-48 of CCS (Pension) Rules, 1972 (now, rule 42 of CCS (Pension) Rules, 2021).

As per these guidelines, the periodic review is to be made by the Review Committee in case the Government servants whose integrity is doubtful or Government servants found to be ineffective. On the basis of above, the fitness/competence to continue on the post, will be ascertained by the Review Committee. *After going through the matter, Executive Council resolved to adopt the guidelines of the Govt. of India related to periodic review of employees for strengthening of administration of University.*

Item No.13.3.5

To report the letter No. F. 39-3/2004 (JCRC) dated 05.08.2024 of the UGC related to the case of Dr.Gyandhar Pathak, Research Assistant of SLBSNSU, New Delhi.

The Executive Council noted the status of the case of Dr. Gyandhar Pathak, Research Assistant of SLBSNSU as per the Order dated 08.05.2024 of the Hon'ble High Court of Delhi in the W.P.(C) 1323/2020 and follow up action taken by the University and decision thereon received from UGC vide letter No. F. 39-3/2004 (JCRC) dated 05.08.2024. EC observed that presently, the matter is again under sub-judice.

Item No.13.3.6

To report the online hybrid mode visit of the Peer Team of the NAAC during 28.05.2025 to 30.05.2025.

It was informed to the Executive Council that the Peer Team of the National Assessment and Accreditation Council (NAAC) (consisting of a Chairman, one Co-ordinator, 5 members and one Co-coordinator) has visited the University from 28th to 30th May, 2025 in hybrid mode. Two members were physically visited the University and other members including Chairman, Co-ordinator/Co-cocordinator were remained in "virtual mode/online mode. During this accreditation visit, the Peer Team has interacted with the members of Executive Council, Academic Council, Alumini, Student Council representatives, Teaching staff, Non-Teaching staff, Vice-Chancellor, HoD/Deans and other officers of the University. The team member (in physical as well as virtual) visited the whole campus of the University and veritified the Class Rooms, Labs, Studio, Yagnshala, DG plant, Works Department, Computer Centre and various academic departments, Centers, EV Station, Crech, Canteen, play grounds, Dispensary, Gym & other facilities available in the Campus. The team also visited to nearly village - Kishangarh (adopted by the University) and a Delhi Government School in respect of teachers educations.



After the aforesaid visit/assessment, SLBSN University accredited with highest ranking of A++ with overall score of 3.55 by the National Assessment & Accrediation Council.

All the members of the Executive Council congratulated the Vice-Chancellor-Prof. Murlimanohar Pathak for this achievement and appreciated the efforts made by him to achieve such a milestone for the University. The members also extended their thanks to the Ministry of Education, Director (IQAC), Registrar of the University, along with entire teaching and non-teaching staff including contractual staff of SLBSNSU, New Delhi for giving their support for this noble cause.

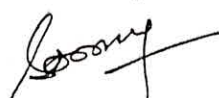

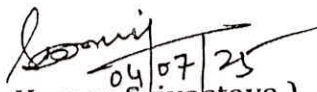

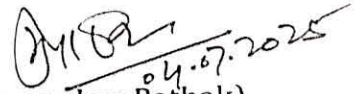
Item No.13.5 Any other item with the permission of the Chair
