Item No.6.5

### To report the submission of the revised Ordinances and Regulations of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi to the Ministry of Education, Govt. of India for approval of the Hon'ble Visitor.

The Executive Council noted the contents of agenda note and observed that in accordance with the letter F.62-4/ 2021(CU) dated 19.01.2022 of the UGC followed by the Resolution No.5.3 dated 21.01.2022 of the Executive Council and the letters No.1-6/2021-Skt.I dated 16<sup>th</sup> Feb., 2022 & 29<sup>th</sup> March, 2022 of the Ministry of Education, Govt. of India, the Ordinances and Regulations were reviewed and finalized by the Expert Committee at its meeting held on 7<sup>th</sup> April, 2022.

Subsequently, in accordance with Clause-11(3) of the Central Universities Act, 2020, the above-mentioned draft Ordinances and Regulations were sent to all the members of the Executive Council for approval through circulation on 13.04.2022. Consequently, after the approval, the above-mentioned Ordinances and Regulations were forwarded to the Ministry of Education for approval of the Hon'ble Visitor.

Thereafter, the Ministry of Education, Govt. of India vide their office letter No.1-6/2021-Skt.II dated 10.08.2022 has forwarded the observations of the UGC as given in their letter No.62-4/2021(CU) Computer No.103638) dated 05.08.2022. As per the observations, the UGC has conveyed their no objection on the Ordinances/Regulations as mentioned at S.No.2 to 12 along with the Rules relating to the Medical Attendance Reimbursement and Allotment of Residential accommodations to the University Employees, 2021.

The observations as given by the UGC in the letter dated 05.08.2022 at S.No.1 under the Ordinance" Admission of Students to the university and their enrolment (for Regulation on Campus Mode) regarding earmarking of 5% seats for the children of Indian workers in the Gulf and South Asian out of the 15% superannuated seats for foreign students in the university departments and provision of refund of fees as per the UGC Notification on Remittance and Refund of fees and other student-centic issues, were incorporated in the abovementioned Ordinance and the revised Ordinance has been sent to the Ministry for approval.

Regarding Ordinance on Recruitment Rules for appointment of Non-Teaching and other Non-Vocational Academic Posts-2021, the Executive Council noted that the UGC is in the process of framing the model recruitment rules which is yet to be approved by the Ministry of Education. Accordingly, the University will be required to submit the Ordinance on Recruitment rules once Model Recruitment Rules are approved by the Ministry.

Further, the Ministry vide their letter No.1-6/2021-Skt.II dated 29.08.2022 has intimated that the UGC has conveyed their "No Objection" to the proposed amendments to be made in the Statutes of the CSU Act, 2020 relating to the provisions of new officers such as Dean Academic Affairs, Dean Student's Welfare, Director-IQAC, Chief Proctor, Proctor, Chief Warden and Hostel Warden of the University. In this regard, the Ministry has requested to intimate

whether the University has any other amendments to be incorporated in the CSU Act, 2020 and if so, the same be furnished to the Ministry immediately so that an exercise will be made to make consolidated amendments instead doing it in peace meal basis. After going through the above-mentioned factual positions, the Executive Council resolved to note the status of the Ordinances and Regulations and the Statutes of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi. The Executive Council further resolved to finalize the draft Ordinances, Regulations and the proposals relating to amendments in the Statutes of the University for approval of the Hon'ble Visitor of the University preferably within the period of three months from the date of confirmation of the minutes.

Item No.6.6

To reconstitute the Expert Committee for preparation of draft Ordinances and Regulations of Shri Lal Bahadur Shastri National Sanskrit University, New Delhi

The Executive Council noted that in accordance with the resolution No. 3.6 dated 13.11.2020 of the Executive Council, the Expert Committee was constituted for preparation and recommending the draft Statutes, Ordinances and Regulations of the University. However, presently there is a need of reconstitution of Expert Committee. After going the proposal, the Executive Council resolved to reconstitute the Expert Committee to finalize the remaining draft Ordinances, Regulations and Statutes of Shri Lal Bahadur Shastri National Sanskrit University with the stipulated time period of three months, as under:-

Item No.6.7

To consider and approve the recommendation of the Screening-cum-Evaluation Committee held on 29.03.2022 regarding promotion of the teaching staff of the University under Career Advancement Scheme of the UGC

The Executive Council considered the minutes of the internal Screening Committee dated 14.03.2022 and recommendations of the Screening-cum-Evaluation Committee dated 29.03.2022 regarding promotion of the Assistant Professors in the Senior Scale from Academic Pay Level-10 to APL-11 under CAS of the UGC. Thereafter, the Executive Council resolved to approve the minutes of the internal Screening Committee and Screening-cum-Evaluation Committee dated 29.03.2022 regarding placement of Dr. Pravesh Vyas, Assistant Professors in the Senior Scale from Academic Pay Level-10 to Academic Pay Level-11 w.e.f. 26.08.2020 as these are in consonance with the provisions of the UGC Regulations, 2018. It was further resolved to confirm the above-mentioned decision on the table for implementation.

To consider and approve the request dated 30.06.2022 of Shri Bipin Kumar Tripathi, OSD to Vice-Chancellor & Research-cum-Statistical Officer (SC/ST Cell) regarding allotment of staff quarters under the essential category.

The Executive Council considered the application dated 30.06.2022 of Shri Bipin Kumar Tripathi, OSD to Vice-Chancellor & Research-cum-Statistical Officer (SC/ST Cell) regarding allotment of Staff Quarters in the University Campus under essential category. The Executive Council observed that being the OSD to Vice-Chancellor, the services of Shri Bipin Kumar Tripathi are essential in nature to carry out the different time bound assignments of the Vice-Chancellor Secretariat of the University during odd hours, Sundays and holidays. Thus his request can be considered on merit in the interest of the university. In view of the above, the Executive Council resolved that the services of Shri Bipin Kumar Tripathi as OSD to Vice-Chancellor be declared as "Essential Category" and the Staff Quarters be allotted to him on priority as per his entitlement beyond the permissible limit of 10% in accordance with the rules of Allotment of Residential Accommodations of the University.

Item No.6.9

To report the status of filling up of backlog reserved vacancies of SLBSNSU, New Delhi

The Executive Council observed that in accordance with the directives issued by the Ministry of Education, Department of Higher Education vide letter No.33-2/2021-TS-III (PLI) dated 24.08.2021, the Ministry has advised several times to fill-up the backlog posts but in the absence of the requisite nominations of the Hon'ble Visitor and Central Government, it has become difficult to convene the meeting of the Selection Committees. Members have advice the University Administration to make more and more efforts for it so that vacancy may be

filled-up at the earliest possible. The Executive Council noted that the vacant teaching posts including backlog positions were advertised vide Advt. No.02/2022 and the whole process of screening of application and filling of backlog posts may be completed at the earliest.
