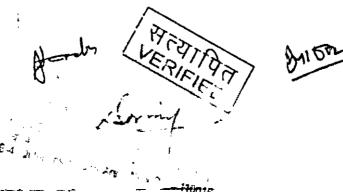

Confirmation of the minutes of the 5<sup>th</sup> meeting of the Finance Committee held on 21:06.2022

The minutes of the 5<sup>th</sup> meeting of the Finance Committee were circulated to all the members. No discrepancies have been pointed out by any member of the Finance Committee. Hence, the minutes were confirmed.

**ITEM NO. 6.2** 

To report the Action Taken on the 5<sup>th</sup> meeting of the Finance Committee held on 21.06.2022.

Action Taken Report on the minutes of the 5<sup>th</sup> meeting of the Finance Committee was presented by the Member Secretary. The Finance Committee noted the same.

To consider and approve the recommendation of the committee constituted to treat Invigilation duty by the Guest Faculties of the University at par with class room teaching for the purpose of payment to Guest Faculties.

The Finance Committee discussed the matter in the light of the recommendation of the internal committee of the University and guidelines of the University Grant Commission with respect to payment to Guest Faculty.

After a deliberate discussion, it was Resolved to approve the agenda item subject to adherence of University Grants Commission guidelines.

# **ITEM NO. 6.4**

To consider and approve the Annual Accounts 2022-23 of Shri Lal Bahadur Shastri National Sanskrit University.

The Annual Accounts 2022-2023 of Shri Lal Bahadur Shastri National Sanskrit University were presented before the Finance Committee. The Finance Committee noted that Annual Accounts have been prepared as per the New Accounting Format and necessary provisions for retirement benefits as prescribed in AS-15 have also been made. The comments of IFD on the item were also perused. After discussion, the Finance Committee Resolved to approve the Annual Accounts 2022-2023 of Shri Lal Bahadur Shastri National Sanskrit University. Further as the Annual Accounts are to be submitted to the Audit Office within a scheduled time-

### **ITEM NO. 6.5**

To consider and approve the engagement of four library interns in the Central Library of the University.

The Finance Committee discussed the issue of shortage of staff in the Central Library of the University in the light of the 04 staff members being on election duty. The future plan for opening of the Central Library on Saturday and beyond normal working hours was also discussed.

Accordingly, the Finance Committee Resolved to approve the agenda item subject to the condition that the total number of staff so hired and staff already posted in Central Library (excluding those on election duty) may not exceed the staff strength sanctioned for the Central Library of the University. Further Resolved that the University will manage the expenditure on above out of its allocated budget/internal receipts.

To consider and approve the Budget Estimates 2023-24 of Shri Lal Bahadur Shastri National Sanskrit University.

The Finance Committee discussed the Budget Estimates 2023-2024 of the University. The Finance Committee also took note of the sanction of BE 2023-24 issued by University Grants Commission.

After a detailed discussion, the Finance Committee Resolved to accord its ex-post facto approval of Budget Estimates 2023-24 of the University.

To consider and approve the extension of the Central Government health Scheme (CGHS) facility to the employees and pensioners of SLBSNSU, New Delhi.

The Finance Committee perused the letter No. 1-8/2022-Skt.1 dated 11<sup>th</sup> October, 2022 of the Deputy Secretary, Ministry of Education, Department of Higher Education. The Finance Committee also perused the information prepared by the University in response to the said letter. The Finance Committee Resolved to approve it for submission to the Ministry of Education, Government of India.

To consider and approve the Budget Proposal and Academic Activities of Bhartiya Bhasha Samiti for the Financial Year 2023-24.

The Finance Committee noted the budget proposal of Bharuya Bhasha Samiti for the year 2023-2024 has already been taken into consideration by Shri Lal Bahadur Shastri National Sanskrit University while submitting its BE 2023-2024 to the University Grants Commission.

Accordingly, the Finance Committee Resolved to accord ex-post facto approval fo the budget proposal and academic activities of Bhartiya Bhasha Samiti for the year 2023-2024.
