In this regard it is advised by the Ministry of Home affairs to the Universities/Boards in state not to charge any fee for verification of education certificates/date of birth etc. from the Central Government Departments. No time limit may be fixed for this concession as it is a never ending requirement.

Verification of Education certificate/Date of birth from University/State Boards.

Sir,

Reference this Ministry's letter of even number dated 08.12.2009.

2. As per Government Instructions, whenever it is found that a Government Servant, who was not qualified or eligible in terms of the recruitment rules etc. for initial recruitment in service, had furnished false information, or produced a false certificate in order to secure appointment, he should not be retained in service. If he is probationer or a temporary Government servant, he should be discharged or his service should be terminated. In case of permanent Government servant, an enquiry as prescribed under rules should be held and if the charge is proved, he should be removed or dismissed from service. In no circumstances should any other penalty be imposed. Whenever action has been taken in such cases, personnel come up in appeal revision and also go to court on the ground that they have served the department for very long period and they should be dealt with sympathetically. To avoid litigation and to reduce scriptory work the Education Certificate/Date of Birth of new entrant are verified from concerned University/Education Board/Distt. Education Officer etc.

3. It has been brought to notice of Ministry of Home Affairs that some of the Education Boards/Institutions are demanding fee from the government departments for verification of education certificate/date of birth.

4. The Department is verifying the correctness of the documents produced by the candidates to ascertain his eligibility for the appointment and to prevent ineligible person gaining employment in the Government through fake certificates thereby denying chances to genuine candidates. The Government is giving employment to youths and it shall be the responsibility and duty of the every Educational Institutions to ensure that only the genuine candidates get the appointment. It shall be in fitness of things that payment for such verification is not demanded from the Government as the process of verification on the other hand establishes the credibility of the University/boards themselves.

5. It is therefore, once again requested that you may consider advising the Universities/State Boards in state not to charge any fee for verification of education certificate/date of birth etc from the Central Government Departments whenever they are sought. No time limit may be fixed for this concession as it is a never-ending requirement.
