Dear Secretary / Chief Secretary,

As you are aware, the Ministry of External Affairs is the nodal Ministry for processing and grant of political clearances for visits abroad by Ministers, Parliamentarians, Legislators and all officials of the Central/State/UT Governments and PSUs.

2. To speed up & streamline the processing of applications for political clearances for visits abroad, the Ministry is launching an e-Political Clearance System on a pilot basis on 1st January, 2016 to enable eligible applicants to apply for political clearances online. This portal - epolclearance.gov.in - can be used for seeking political clearance of the MEA for all outgoing visits that require such clearance. This is an initiative under the ambit of the Digital India program to improve delivery of services by the Ministry and is hosted on the GI Cloud with the support of NIC.

3. In order to promote the use of this online portal, I request you to kindly encourage all Departments/Organisations/Institutions/Divisions under your charge to begin using this portal for submitting applications for political clearance to the MEA. On successful completion of this pilot phase, we envisage making online applications mandatory. An overview of this portal with salient features is attached for your kind reference.
