#### 4.3.1 Institution frequently updates its IT facilities.

Shri Lal Bahadur Shastri National Sanskrit University: The university provides IT resources to support academic, research, and administrative activities, enhancing efficiency and productivity. The IT policy applies to faculty, staff, students, alumni, guests, and related institutions. IT resources encompass all hardware, software, and devices connected to the university's network, whether physical or wireless. The policy's primary goal is to ensure legal, ethical, and university-related use of these resources, regulating access and preventing misuse.

The Computer Centre is the primary body responsible for implementing the IT policy, ensuring secure and proper use of IT infrastructure. It addresses security-related incidents, providing necessary support to users. The policy encourages the use of IT for academic and research purposes aligned with university objectives.

Users must comply with national and state regulations, including telecommunications, intellectual property, and software licensing laws. Installing network or security devices requires consultation with the university's Information Assurance team. The entire campus is equipped with Wi-Fi, supporting connectivity across all departments.

#### **Important Points:**

- 1. When other policies impose stricter limitations than this IT policy, the stricter policy will take precedence.
- 2. All users are expected to respect the privacy and confidentiality of others in the use of IT resources.
- 3. Without the approval of the competent authority, users cannot copy emails, data, or programs.

Antivirus protection is installed on computers, and regular updates are carried out. Hardware maintenance and cleaning are performed by the relevant technical staff, including cleaning hard disks, upgrading wireless keyboards, and installing new technology. High-quality printers are also installed on campus. The increased speed of the internet via Wi-Fi is very beneficial for students, teachers, and staff. The university regularly updates and enhances the Wi-Fi system.

**COVID-19 Impact:** During the COVID-19 pandemic, the internet was the primary means of communication between students and teachers. The university follows the Indian Government's "Digital India" initiative and strives to implement it successfully. As a result, paperless transactions are conducted within the university and offices. Employee salaries, student scholarships, research fellowships, and other payments are processed electronically.

**Internet Access:** The university provides internet access throughout the campus, with facilities available in every room. All computers in offices are connected to the internet, including the examination department. Internal telecommunication systems (intercom) connect the various departments, with MTNL as the primary service provider. MTNL is funded on a monthly and annual basis, and 1 Gbps internet connectivity is provided through the IT project of the Ministry of Human Resource Development (MHRD).
