MEMORANDUM OF UNDERSTANDING

(Regular Study Centre)

Signed between Indira Gandhi National Open University, hereinafter referred to as 'IGNOU', and Head of the Host Institution, regarding the Organizational representations the proposed Study Centre at SHRI LAL BAHADUR SHASTRI RASHTRIYA SANSKRIT VIDYAPEETHA (Deemed University) Qutub Institutional Area New Delhi - 110016

I. The Host Institution will:

- give 3 to 4 rooms with a space of approx. 800-1000sq. ft. for exclusive use of IGNOU Study Centre without charging any rent.
- let a signboard of IGNOU Study Centre be installed prominently at a proper place.
- ensure security of the equipment provided by IGNOU.
- make halls/rooms available for holding IGNOU examinations.
- extend library, laboratory and computer facilities to IGNOU students for specialized programmes requiring use of institutional infrastructure facilities on mutually agreed terms.


The Head of the institution shall have the right to -

- recommend a panel of three names to IGNOU for the appointment of Coordinator.
- inspect the Study Centre whenever he/she likes and advise the Co-ordinator, and also write to the Regional Director


II. IGNOU will:

- provide furniture and equipment for the Study Centre as per norms.
- bear all recurring and non-recurring expenditure on maintenance of the Study Centre.
- pay contingent charges and other remuneration for holding examinations.
- appoint part-time Coordinator from the panel recommended by the head of the institution and pay him honorarium at the rates in force from time to time.
- appoint Part-time Class-III and Class-IV staff and other Study Centre functionaries on the basis of recommendation of the Coordinator and pay them remuneration at the rates in force from time to time.
- pay an honorarium to the Head of the institution for general supervision of the Study Centre as fixed by IGNOU from time to time
- have the right to shift or close the Study Centre if it finds that support services are not being provided, as per the requirements of the university. In such case the Coordinator would have to hand over all the assets and academic records of the learners to the Regional Director. The Coordinator will also have to settle all financial accounts with the Regional Directors.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding made on this sixteenth day

School of Planning and Architecture (SPA), New Delhi, with head office located at 4-B, Indraprastha Estate, New Delhi 110002, hereinafter referred to as the **FIRST PARTY**, which expression shall mean and include its representatives, successors and assigns

AND

Shri Lal Bahadur Shastri National Sanskrit University, New Delhi with head office located at Qutub Institutional Area, New Delhi 110016, hereinafter referred to as **SECOND PARTY**, which expression shall mean and include its representatives, successors and assigns

HEREBY WITNESSEETH AS FOLLOWS:

WHEREAS the SPA New Delhi, whose origins date back to the year 1942, is an 'Institution of National Importance' under an Act of Parliament, funded by the Ministry of Education, Government of India as an apex premier national level institution engaged in education (offering undergraduate, post graduate and doctoral degrees), research, consultancy and training activities related to architecture, planning, housing, real estate and related fields in the area of human habitat and built environment, and

WHEREAS the Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU), New Delhi established in the year 2020 is a 'Central University', accredited 'A' Grade under NAAC, under the Ministry of Education, Government of India, imparting Sanskrit education at undergraduate, post graduate and doctoral levels and also engaged in providing an interdisciplinary platform for advisory, capacity building, research, consultancy services and dissemination of information in the area of Sanskrit and related areas, and

WHEREAS heads of both the above organizations met and discussed areas of mutual interest and benefit and expressed a desire to exchange and collaborate for the benefit of the nation at large, in tune with the policies of the Government of India,

THEREFORE, NOW HEREBY, THIS MEMORANDUM OF UNDERSTANDING WITNESSEETH AS FOLLOWS :

THAT SPA New Delhi and SLBSNSU, New Delhi shall exchange and share knowledge, papers and reports, where ever feasible, on various aspects of architecture, Vaastu Shastra and related subjects,

THAT SPA New Delhi and SLBSNSU, New Delhi shall design and conduct, where ever feasible, various academic, research, training and capacity building programmes of varying duration,

THAT this MoU does not envisage any financial commitment from either of the parties who are signatory to this Memorandum and if there are any financial commitments, they shall be deliberated, decided upon and agreed to, as and when the need arises through separate agreements, as and when required.

THAT both parties may undertake any such activity which is of mutual interest to the parties concerned and in tune with the policies of the Government of India, in the interest of the nation.

THAT in order to coordinate and carry out the activities envisaged in this MoU, both parties shall identify suitable persons in their respective organizations as Nodal Officers, and,

THAT this MoU is entirely voluntary in nature from both parties, shall be valid for a period of five years from the date of signing and can be modified and/or extended on mutual consent, by giving a notice of three months on either side and terminated by either party, without according any reason, by giving a notice of three months on either side.

Memorandum of Understanding (MoU) for Shodhganga/Shodhgangotri
(A Repository of Theses and Dissertations submitted to the Universities in India)

This Memorandum of Understanding (MoU) is made and entered into on _____ (Day) _____ (Month) _____ (Year) between the INFLIBNET Centre, an IUC of University Grants Commission located at Gandhinagar, hereinafter referred to as "INFLIBNET" and SUBS Rashtriya Sanskrit Vidyapeetha (University / Deemed University / Inter-University Centre), here in after referred to as the 'University'.

WHEREAS, INFLIBNET Centre, an Inter-university Centre of the University Grants Commission, as its mandate, promotes open access to scholarly content generated in universities. The Centre has computers, network, software infrastructure and technical know-how required for hosting electronic versions of theses and dissertations in open access with interface to search, retrieve and access these content.


WHEREAS SUBS Rashtriya Sanskrit Vidyapeetha (University / Deemed University / Inter University Centre) has agreed to take part in the process of digitisation of old theses and dissertations (not available in computerized machine-readable format) and building-up of digital repository and to promote, share and host its ETD in 'Shodhganga: A reservoir of Indian theses submitted to the Universities in India' and other universities in open access. 'Shodhganga' is a name coined by INFLIBNET Centre for referring to the repository of Indian Electronic Theses and Dissertations. The word "Shodh" originates from Sanskrit and stands for research and discovery. The 'Ganga' is the holiest, longest and largest river in Indian subcontinent which has held heart of its people captive and drawn millions of people to its banks since the dawn of history. The Ganga is the symbol of India's age-long culture and civilization, ever changing, ever flowing, ever loved and revered by its people. "Shodhganga", a repository of theses and dissertations submitted to Indian universities, is expected to keep growing to a formidable size as more and more researchers from India submit their research works to this ever growing reservoir. Under the initiative called "Shodhgangotri", research scholars / research supervisors in universities are requested to deposit electronic version of approved synopsis submitted by research scholars to the universities for registering themselves for the Ph.D programme.

This Memorandum of Understanding (MoU) defines responsibilities, liabilities and commitments of the institutions involved to ensure proper system implementation, to meet the objectives pertaining to submission and access to Electronic Theses and Dissertations as envisaged by the UGC vide its Notification (Minimum Standards & Procedure for Award of M.Phil/Ph.D Degree), Regulation, 2009 dated 1st June, 2009.

NOW, THEREFORE, in consideration of the mutual agreements herein contained, INFLIBNET and the University agree to the following terms and conditions:

1. INFLIBNET Centre

1. Provide access to ETD hosting server(s) at the INFLIBNET Centre 'Shodhganga'/Shodhgangotri' to the University with accompanied software interface enabling University / its student to create metadata and upload their theses and dissertations in ETD repositories designed for this purpose. The INFLIBNET will take the responsibility of keeping the data intact and usable, keep back-up of the data so as to avoid its loss. The INFLIBNET will deploy



tools and techniques of digital preservation to ensure continuing access to scholarly content in digital formats and to protect them from media failure, physical loss and obsolescence.

2. Recommend to the UGC to extend financial assistance to the Universities under Sections 12(B) and 2(f) of UGC Act for digitization of theses and dissertations not available in computerized machine-readable format and / or for procurement and installation of a suitable computer system / infrastructure for creation of ETDs.
3. Provide configuration of system, specifications and technical guidance to the University for procurement of computer hardware and related systems for setting-up of ETDs.
4. Provide guidelines, technical standards and specifications for digitization of Ph.D. theses submitted to the university in past and for theses not available in computerized machine-readable format.
5. Impart training to at least one person from the university (from library field and / or from computer field) in creation, updation and computerized operation of digital repositories of ETDs especially on 'Shodhganga'.
6. Extend access to an anti-plagiarism software or provide services to evaluate theses for possible plagiarism and submit a report to the concerned university.
7. The INFLIBNET may refuse to host any material deemed by the INFLIBNET to be controversial in nature or is in violation of copyright act.
8. This right of refusal will not relieve the University / Ph.D. scholar of liability, both to INFLIBNET and to the public, for matter contained in the theses that may be libelous or actionable and to both INFLIBNET and copyright owners for copyright infringement by the Ph.D. Scholar.
9. The INFLIBNET Centre will not be responsible for i) errors, omissions, inaccuracies and quality of content or misinformation or for any damages caused to the user or any third party from the use of content provided in the theses; ii) safety and archiving of loaded content in cases of "force majeure" including natural calamities; and iii) printed version of theses.
10. INFLIBNET Centre will recommend or provide access to plagiarism software which university may use to detect plagiarism before awarding the degree.
11. The INFLIBNET Centre replicates the content of theses and dissertations on different server and other auxiliary storage media. However, the INFLIBNET Centre does not take the responsibility for the archiving or backing-up of loaded content. The universities, therefore, should also keep a back-up of their theses and dissertations.

12. INFLIBNET Centre also maintains a repository called "Shodhgangotri" for hosting the approved synopses of research topic submitted to the universities by the students for registering themselves under the doctoral programme. Research students/their supervisors are encouraged to submit approved synopses/research proposals and register their priority on a research proposal through the repository.

II. The University

1. The University would grant non-exclusive worldwide license to the INFLIBNET Centre for hosting and distributing their theses in digital format in 'Shodhganga'/'Shodhgangotri' or any other server designated for this purpose.
2. The University / its researcher scholars agree to host / upload a computerized machine-readable file in mutually agreed format of all theses on to the 'Shodhganga'/'Shodhgangotri' server at the INFLIBNET.
3. The University will not hold INFLIBNET Centre responsible for any errors and omissions contained in the original theses.
4. The University commits to digitize theses and dissertations and their bibliographic records submitted to the university and provide necessary infrastructure including manpower support for operation of ETDs.
5. Commits to utilize the assistance provided by the UGC on recommendation of the INFLIBNET for implementation of ETDs including their digitization.
6. Deputes at least one person from the university (from library field or from computer field) for undergoing training on implementation of ETD organized by the INFLIBNET and ensure that the person trained by INFLIBNET on ETD is / are deployed for the same job.
7. Arranges to provide training to research scholars or users of its library and staff of colleges affiliated to University in creation of electronic version of theses and their deposition in the ETDs.
8. Ensures use of standard software and metadata schema suggested / provided by the INFLIBNET for setting-up / development / operation of its ETDs.
9. Creates bibliographic records of all theses and dissertations submitted to the university in standard bibliographic formats prescribed by the INFLIBNET Centre from time-to-time and contributes these records for inclusion in the INFLIBNET's Union Catalogue (IndCat).
10. Commits to sharing of library ETD resources / databases with the INFLIBNET Centre as well as with other universities.

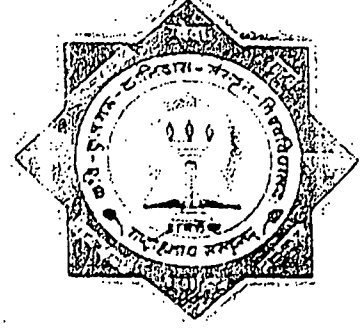

MEMORANDUM OF UNDERSTANDING

Kavikulaguru Kalidas Sanskrit University (KKSU), Ramtek, is an institution dedicated to the advanced learning of Sanskrit which is the First Sanskrit University of Maharashtra. The University, along with providing regular course works. KKSU is unique in nature which focuses on a modern approach to the Sanskrit language. In addition to preserving traditional Sanskrit, it emphasizes on the study of science and technology in ancient India, which is exclusively described in old Sanskrit texts. KKSU of the FIRST PART.

And

Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) has been established as Central University and start functioning as Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU), New Delhi-16 w.e.f from 30th April, 2020 under the Central Sanskrit Universities Act, 2020 (no.5 of 2020 dated: 25th March, 2020) as enacted by the Parliament and assented to by the President of India and duly published in the Gazette of India by the Ministry of Law & Justice, Govt. of India. Legislative department followed by the Gazette Notification F.No. 4-4/2018-Skt-II dated: 17.04.2020 of the Ministry of Human Resource Development, Department of Higher Education (Language Division, New Delhi).

The Akhil Bharatiya Sanskrit Sahitya Sammelan established a Sanskrit Vidyapeetha at Delhi on the auspicious day of Vijaya Dashmi on the 8th of October 1962 and appointed Dr. Mandan Mishra as the officer on Special-Duty and the Director of the Vidyapeetha. On the 2nd October 1966 that the Vidyapeetha renamed as Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha. On 1st April, 1967, the Vidyapeetha was taken over by the Government of India and on the 21st December 1970, it became a constituent of the Rashtriya Sanskrit Sansthan, a registered autonomous Society and was named as Shri Lal Bahadur Shastri Kendriya Sanskrit Vidyapeetha.

- Promotion & Propagation of Sanskrit & its allied subjects will be carried out mutually through seminars / workshops / conference / symposium etc.

Babasaheb Bhimrao Ambedkar Bihar University popularly also known as **B. R. Ambedkar Bihar University (BRABU)**, is a state university located in the north prime of Bihar state in the city of Muzaffarpur. The B. R. Ambedkar Bihar University was separated from Patna University on 2nd January 1952. The Bihar University Act 1960 bifurcated University of Bihar into three separate entities, i.e. (1) Bihar University, Muzaffarpur (2) Ranchi University, Ranchi (3) Bhagalpur University, Bhagalpur. Article 1:

Babasaheb Bhimrao Ambedkar Bihar University (BRABU), Muzaffarpur, Bihar has signed a MoU with Shri Lal Bahadur Shastri National Sanskrit University (SLBSNSU) New Delhi. The purpose of MoU is to undertake training program, Students and Faculty Exchange Programs, Skill development programs to conduct short term courses in mutual understanding, Study and Editing of Manuscripts, Translation works joint research, site visits and development of all such programs which will benefit students, teachers and academic environment including academic administration of both the institutes. The goal of this collaboration is to fulfil the aims and objectives of National Education Policy 2020 (NEP 20) and meet the rapidly growing educational need by leveraging mutual capabilities.

BRABU and SLBSNSU agree to explore the possibility of engaging in the following mode of collaboration.

- Exchange of information on Research and Design- Students and Faculty Exchange Programs,** Teaching learning materials, Manuscripts and other sources relevant of Sanskrit and its allied subjects through meetings and discussions and direct contribution through designs projects. Also, Development of educational and training programs for institutional development. **Experiential learning through Hands on training and workshops-** Students will be encouraged to participate in skilled development programs to gain knowledge through learning by doing studies through exchange programme.
- Joint organization-** Joint organizations of seminars workshops on respective field while extending invitation to each other's contact to participate therein.
- Sharing expertise-** Providing expertise in up gradation of teaching-learning and research skills along with Exchange of documentation, research materials, publication, and information in fields of mutual interest.
- Under this MoU the Centre for Distance and Online Education (CDOE), a study centre will be started in mutual subject and facilitate each for obtaining the approval from UGC, Govt. of Bihar, Govt. of India New Delhi and concerned authorities..
- Promotion & Propagation of Sanskrit & its allied subjects will be carried out mutually through seminars/workshops/conference/symposium etc.
- Both University will also work and show their expertise in respect of implementation of NEP-2020, Examination matter, other academic matter, academic administration etc.

Article 2:

The Memorandum shall remain in force for a period of Three years commencing from effective date 19.07.2024. Both parties may extend the term by written agreement signed by both after necessary review.

No amendment or modification of this MoU shall be valid unless the same is made in writing by both the parties and their representatives specifically stating the same to be amended in this MoU. The modification/changes shall be effective from the date on which they are made executed, unless otherwise agreed to.

Article 3:

Once terminated neither party will be responsible for any losses, financial or otherwise which the other party may suffer.

WHEREAS the Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (SLBSRSV), New Delhi established in the year 1962 is a 'deemed University', accredited 'A' Grade under NAAC, under the Ministry of HRD, Government of India, imparting Sanskrit education at undergraduate, post graduate and doctoral levels and also engaged in providing an interdisciplinary platform for advisory, capacity building, research, consultancy services and dissemination of information in the area of Sanskrit and related areas, and

WHEREAS heads of both the above organizations met and discussed areas of mutual interest and benefit and expressed a desire to exchange and collaborate for the benefit of the nation at large, in tune with the policies of the Government of India,

THEREFORE, NOW HEREBY, THIS MEMORANDUM OF UNDERSTANDING WITNESSEETH AS FOLLOWS :

- THAT SPA New Delhi and SLBSRSV, New Delhi shall exchange and share knowledge, papers and reports, where ever feasible, on various aspects of architecture, Vaastu Shastra and related subjects,

- THAT SPA New Delhi and SLBSRSV New Delhi shall work, where ever feasible, on research and consultancy projects,
- THAT this MoU does not envisage any financial commitment from either of the parties who are signatory to this Memorandum and if there are any financial commitments, they shall be deliberated, decided upon and agreed to, as and when the need arises, through separate agreements, as and when required,
- THAT both parties may undertake any such activity which is of mutual interest to the parties concerned and in tune with the policies of the Government of India, in the interest of the nation,
- THAT in order to coordinate and carry out the activities envisaged in this MoU, both parties shall identify suitable persons in their respective organizations as Nodal Officers, and

Shri Lal Bahadur Shastri National Sanskrit University, New Delhi, India represented by the Registrar, SLBSNS University, New Delhi hereinafter called as the 'FIRST PARTY' which expression shall unless repugnant to the context mean and include its successors, assignees, representatives and administrators of the one part as First Party

AND

BAPS Swaminarayan Research Institute represented by its ~~Director~~ ^{Head Bhadrashilas} ~~Shri J.M.~~ hereinafter called as the 'SECOND PARTY' which expression shall unless repugnant to the context mean and include its successors, assignees, representatives and administrators of the other part as Second Party.

WHEREAS

1. The Ministry of Education, Government of India has established the Shri Lal Bahadur Shastri National Sanskrit University, New Delhi, India through the Central Sanskrit Universities Act, 2020 as a Central University. Prior to the enactment, SLBSNSU was known as Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi, India as a Deemed-to-be University.
2. BAPS Swaminarayan Research Institute, New Delhi represented has established for promotion and propagation of Sanskrit Language and Literature through various subjects such as Vedanta, Akshra Purushothama Darshana, Vyakarana, Nyaya, Sahitya and Karmakanda.
3. WHEREAS the Second Party approached the First Party (Shri Lal Bahadur Shastri National Sanskrit University) for forging an alliance by entering into a Memorandum of Understanding to exchange journals published by respective organizations between them, exchange of students and teaching staff for furtherance of promotion and propagation of Sanskrit Language and Literature.

4. Both the parties agreed to take the following steps in furtherance of achievements of the purpose of the MoU:

Both the Parties are responsible for the following activities.

Exchange of Journals:

The two parties agreed to exchange journals published by respective organization on free of cost.

Exchange of students:

The two parties agreed to exchange male students (not more than 10) in a semester in the level of Shastri, Darshana subject for a period of ten (10) days to enlighten their knowledge and vision as there is no provision of accommodation and food to female students at BAPS Swaminarayan Research Institute, New Delhi. During the exchange program TA is to be borne by the students. Accommodation and food is to be provided by respective organization at free of cost.

Exchange of Teachers for enlightenment of knowledge:

The two parties agreed to exchange teachers on Akshra Purushothama Darshana and Vedanta on mutual understanding. The TA is to be borne by the sponsoring institution. Accommodation and food is to be provided by loanee institution on free of cost.

The two parties agreed to make MoU for a duration of two Academic years from 2023-24 to 2024-25 i.e., upto 31-05-2025.

5. There will be no financial liability of both parties. This is totally non financial MoU aggrement.

6. Intellectual Property Rights:

Intellectual Property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be the property of First Party.

7. Termination / Amendment of MoU:

Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by amicable means. If this not be possible because of irreconcilable differences, then this MoU may be terminated by the two parties.

- ✓ Either party may terminate this MoU by written notification signed by the appropriate official of the Party initiating the notice. The intermediary expenditure has to be paid by the Second Party.
- ✓ A minimum of three months prior notice must be sent to the other party prior to the effective date of termination.


8. Jurisdiction:

All disputes are to be settled within the jurisdiction of Delhi High Courts in the State of Delhi.


9. Undertaking:
