RESERVATION POLICY FOR ADMISSION

Reservation of Seats

Central Government and UGC has been issuing various instructions from time to time for implementing the Reservation Policy in admission. The University is strictly following the Reservation Policy, applicable for admissions.

Reservation of seats shall be in accordance with the provisions of the Central Educational Institutions (Reservation in Admission) Act 2006 and Circulars of Government of India and OM No.: 12-4/2019-U1, dated: 17th January, 2019 'Reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions' issued and amended in this regard from time to time.

1. Candidates seeking admission under the reserved categories shall be required to fulfill the prescribed eligibility conditions for admission to the Course.
2. The relaxation in the minimum prescribed percentage of marks in the qualifying examination for admission to a Course shall be permissible only in one of the categories.
3. If a candidate in the reserved category qualifies for admission in the general category he/she shall be transferred to the general category without prejudice to the number of seats already allocated in that category, which will be offered to the next eligible candidate available in that reserved category.
4. If sufficient number of candidates are not available in OBC category, such vacant seats shall be transferred to the general category.
5. The Reservation policy for admission are as follows;

1)	Scheduled Caste (SC)	15% of total intake in each course
2)	Scheduled Tribe (ST)	7.5% of total intake in each course
3)	Other Backward Classes (OBC)	27% of total intake in each course
4)	Economically Weaker Section (EWS)	10% other than total intake in each course
5)	Persons with Benchmark Disabilities (PwBD) quota	3% of total intake (1% each for the persons with low vision or blindness, hearing impaired and locomotors disability or cerebral).
6)	Children/Widows of the eligible Armed Forces Personnel reservation (CW Category)	5% of the seats in the course.
7)	Foreign Nationals	5% seats in each course in Departments/ Colleges for admission under

6. If sufficient number of candidates is not available to fill up the seats reserved for Scheduled Tribes, they may be filled up by suitable candidates from Scheduled Castes and vice-versa.
7. Candidates belonging to Scheduled Castes and Scheduled Tribes will be given relaxation to the extent of 5% in the aggregate of marks obtained in the qualifying examination.
8. The Application Form of a candidate in this category must be submitted alongwith a valid Certificate for Verification, issued from one of the following authorities:
 - a. District Magistrate/Additional District Magistrate/ Collector/Deputy Commissioner/ Additional Deputy Commissioner/Deputy Collector/First Class Stipendiary Magistrate/City Magistrate (not below the rank of First Class Stipendiary Magistrate /Sub-Divisional Magistrate/ Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
 - b. Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate.
 - c. Revenue Officer not below the rank of Tehsildar.
 - d. Sub-Divisional Officer of the area where the candidate and/or his/her family normally resides.
 - e. Administrator/Secretary to Administrator/Development Officer (Lakshadweep) and Minicoy Islands).
 - f. An Application Form received without valid certificate, is liable to be rejected.
9. The vacant seats of SC/ST which could not be filled, due to non-availability of either Scheduled Caste or Scheduled Tribe candidates or both, with the pass marks in the entrance test, if any, may be thrown open to the general category in that year provided this has been notified to the Special Commission for Scheduled Castes/Tribes of University Grants Commission and Ministry of Human Resource Development and concurrence has been obtained.

As per directions of the Ministry of Education/UGC, the University will nominate Liaison Officer for monitoring the implementation of reservation policy in the University.

If, at any time, it is discovered that a candidate has made a false or incorrect statement or other fraudulent means have been used for securing admission his/her name shall be removed from the rolls of the University. Alteration/modification issued by UGC/MoE/GOI on time to time will remain applicable.
