The member Secretary apprised the committee about the existing Cadre Recruitment Rules, the present sanctioned strength of the teaching and non-teaching posts of the Vidyapeetha, Advertisement No.01/2016, 02/2016 and Reservations Rules of the Govt. of India. Subsequently, the Committee considered the draft Reservation Roster for the year 2016 to provide the reservation to the SC/ST/OBC/PWDs categories in the teaching and non-teaching posts of the Vidyapeetha. Consequently, the committee held discussions on various issues before initiating the tasks and also relied upon the following guidelines:

- 1. In case of cadres having more than 13 posts, all appointing authorities should maintain reservation registers and there will be no replacement.
- 2. Reservation Roster Register will be maintained for cadres having less than 14 posts and there will be no replacement.
- 3. Separate registers/roster registers shall be maintained for appointment made by direct recruitment and promotion.
- 4. The reservation roster of single post should not be prepared as per the Govt. of India rules.
- 5. The isolated posts be grouped with posts in the same class for purpose of reservation by taking into account the status, salary and qualifications prescribed for the posts in question as per the Govt. of India rules.
- 6. Out of the total sanctioned posts, 15% of the posts should be earmarked for Scheduled Castes, 7.5% for Scheduled Tribes, 27% for OBC and 3% horizontal reservation for the Differently-abled persons (VH, HH & OH) in teaching and non-teaching posts.
- 7. As per the Govt. of India guidelines, a separate 100 Point Reservation Roster be maintained for determining / effecting reservation for the PWD for each group of posts i.e. 'A', 'B' and 'C'. Accordingly, the Point Nos. 1, 34 and 67 are reserved for persons with disabilities. Ideally, the reservation meant for PWD is to be filled up from the sub-categories of blind or low vision, Hearing Impairment (MH) and locomotor disability or cerebral palsy. The reservation of posts for PWD in direct recruitment shall be maintained for posts Group wise i.e. A, B & C and not post wise. A separate reservation roster be maintained for the posts earmarked in the Cadre Recruitment rules under promotion quota as per the applicable roster.

On detailed deliberations over the issue, the Rostering Committee finalized the cadre-wise Reservation Roster/Reservation Register for the year 2016 in respect of Teaching and Non-Teaching posts for implementation of the reservation policy at Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha. The cadre-wise Reservation Roster in respect of Teaching and Non-Teaching positions as finalized by the Committee on 28.6.2016 are annexed at Annexure-I & II respectively.
