MINUTES OF THE COMMITTEE HELD ON 17.02.2011

Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha is in receipt of letter from Mahanagar Telephone Nigam, New Delhi regarding internet connection of 1 GBPS Link as per the MME –ICT Project of Ministry of HRD, Govt. o India. A committee was constituted by the Vice Chancellor to examine the requirement of Vidyapeetha vis–a-vis the proposal of MHRD to provide 1 Gbps link between University and NKN Pop.

The First meeting of the committee was held on 17.02.2011 at 2:30P.M. in the Committee Room of CWS. The following members were present:

Recommendation of the Committee

The committee deliberated in detail the proposal sent by MTNL in the light of the letter of the Ministry of HRD on the above mentioned subject and found that the proposed linkage and facility would provide the following advantages to the Vidyapeetha.

- 1. The facility will improve the pedagogy in all the courses of the Vidyapeetha and the students of the Department of Education in particular will get more advantages in terms of enhancing their technological skills in teaching.
- 2. The Vidyapeetha will be in position to create virtual class rooms. The Lecturers of the faculty of Vidyapeetha may be made available to all the Universities and colleges which will be connected through this 1GBPS Link and the contents/knowledge available with other university will also be available to the students/teachers of the Vidyapeetha. This will enhance the accessibility of the Vidyapeetha to the global knowledge pool which will be instrumental in upgrading the quality of knowledge dissemination and propagation of Sanskrit across the World at a faster pace.
- 3. This will enable the teachers/researchers/students of Sanskrit to be more technosavy, who are by and large traditional.
- 4. This will help create a strong network of Sanskrit scholars & professional engaged in propagating the relevance and cause of Sanskrit and integrating their knowledge and wisdom with modern subjects through audio and video teleconferencing.

As per the details provided in the letters of MHRD and MTNL, it is observed that the total cost of the project is Rs. 2 crore for a period of 10 years. As per the terms and conditions, 25% of the cost will have to be borne by the University concerned and the rest 75% will be borne by the Government. In this case, the Vidyapeetha will have to pay Rs. 50 lakh for obtaining the said internet/broad band line. In course of discussion Dr. Naqvi briefed the members that in the meeting convened by BSNL on feb,04, 2011 at MTNL Bhawan, New Delhi. BSNL officers had suggested that they may provide the connectivity to Universities and colleges even if they only issue a letter of intent to them. Their officers further suggested to even enter tin requests for payment of work in installment. The committee suggests that in case of paucity of funds, Vidyapeetha may also explore the possibility of paying the share to MTNL in installments.

Your kind attention is invited to the MHRD letter as cited above. In this regard it is stated that under NME-ICT project MTNL is to provide

i. 1 Gbps link between University and NKN PoP

- ii. 10 Broadband over Virtual Private Network connections @ 512 kbps speed to each of college/institutes affiliated to Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapith University during first year which will be increased to 15 & then 20 in second and third year.
- iii. Setting up of university LAN of 400 nodes per university.

The details of the 1Gbps link and BBoVPN plan & University LAN envisaged by MHRD are as below:

1 Gbps Link: - One time charges of Rs 2 crores for 1 Gbps link to each university for 10 years.

Broadband over VPN services: - The growth BBoVPN connections to such colleges/institutes will be 1st yr- 10 connections, 2nd yr- 15 connections & 3rd yr -20 connections (Total 20 connections per college/institute at the end of 3rd year). The plan (BBoVPN - 512 unlimited combo) is as under

Setting up of university LAN or any means per university

Financial obligations are as under (Extract from draft MoU):

- 10% of the cost has to be borne by BSNL & MTNL, being a stakeholder and this would be practically implemented by raising a bill of 90% of the total amount.10% will be passed on as trade-discount.
- 75% of the cost of the project will be borne by the ministry of HRD. 0
- 25% of the project cost will be charged from University/educational institutes 6 by BSNL & MTNL directly.
- All taxes will be charged extra as may be applicable from time to time.
 - For LAN setup charges, as and when the bill is charged from BSNL/MTNL by the LAN vendor. For LAN set-up charges, payment will be made back-to-back on receipt of payment i.e. bill is to be raised by the vendor first. BSNL/MTNL will add its commission of 15% on it. Then a trade discount of 10% on the BSNL/ MTNL's share would be given."

It is intimated that demand note for 1 Gbps link for the amount Rs.4963500/- pertaining to 25% of the amount to be paid by the respective university has already been issued by MTNL in the name of your university and the implementation process has been initiated as per directions of MHRD.

It is therefore requested to kindly:

- a. Arrange for the payment of the demand note as stated above.
- b. Issue suitable instruction to all the colleges/Institutions affiliated to your University, regarding provisioning of broadband services and making payments of 25% contribution.
- c. Arranges to provide list of all such colleges/Institutions along with contact details of Nodal officers so as to facilitate the provisioning and making the project successful.
- \checkmark d. Submit your consent for creation of University LAN so as to facilitate MTNL to take appropriate action in this regard.
