In order to fulfill the vision and mission of late Lal Bahadur Shastri ji former Hon'ble Prime Minister of India under whose Chairmanship Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha was founded and had a dream ...*"to make this institution as a Central institution where not only the scholars from India but also from around the world will come and live teaching studying Sanskrit, noting the research that is being done and themselves work in Sanskrit living here...(So that)...the Vidyapeetha becomes an ideal institution whose shape in the capital of India would be what naturally it should be of such an institute"*... and to meet the long pending demands of the Sanskrit aspirants acrossed the country and need of providing a platform to the National and International Sanskrit scholars, it was felt that there should be a Central Sanskrit University as established by the Govt. of India in other languages in the country. Accordingly, the issue of conversion of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi as Central University was placed before the Academic Council at its 7th meeting held on 03.04.2017 for consideration. The Academic Council after detailed discussion resolved to authorise the Vice-Chancellor to constitute a High Level Committee to examine the issue and prepare a report related to conversion of the Vidyapeetha as Central University. The recommendations of the Academic Council were approved by the Board of Management vide Resolution No.16.4 (III) dated 07.04.2017 with a direction to prepare and submit a comprehensive proposal to the Ministry of Human Resource Development, Govt. of India for consideration.

In view of the above, the Vice-Chancellor constituted a Committee consisting of the following members for the purpose:-

In view of the mandate given to the Committee, the Committee met on 10.07.2017, 03.08.2017, 22.08.2017 and 08.09.2017 and after indepth discussion and deliberations submitted its report on 04.10.2017 with the following recommendations:

"Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha should be promoted and institutionalised as Central Sanskrit University located in the capital city of the country."

Accordingly, as per the decision of BoM, the Vice-Chancellor met the Hon'ble Minister of HRD and presented the report of the Committee on 27.12.2017. The then Hon'ble Minister of HRD agreed in principle on the recommendations made by the Committee. The Language Division of the Ministry of HRD directed the Vidyapeetha to prepare a draft Cabinet Note and Act for conversion as Central University vide letter dated 14.08.2018. The draft Cabinet Note and draft Bye-Laws (Act & Statutes) of the Central University was submitted to the Ministry of HRD on 20.08.2018.

Meantime, after general election, Dr. Ramesh Pokhriyal Nishank took over the charge as Minister of HRD, Govt. of India and directed the concerned Department of the Ministry to take up the issue under 100 days Action Plan which was assigned by the Hon'ble Prime Minister of India to all the Ministries.

The Ministry of Human Resource Development and the Ministry of Law & Justice, Govt. Of India, Legislative Department approved the proposal with certain changes in the Act & Statutes of the Central University. Subsequently, the Bill was approved by the Cabinet on 04.11.2019 which was presented before the Lok Sabha by the Hon'ble HRM on 11.12.2019. After detailed discussion in the Parliament, the Bill was passed in the Lok Sabha on 12.12.2019. Consequently, with the approval of the Hon'ble President of India, the Central Sanskrit University Act was again placed before the Rajya Sabha on 02.03.2020 which was passed on 16.03.2020.

In accordance with Clause 3(1) (b) of the Central Sanskrit Universities Act, 2020 (No. 5 of 2020 dated 25th March, 2020) duly published in the Gazette of India by the Ministry of Law & Justice, Govt. Of India, Legislative Department followed by the Gazette Notification F.No.4-4/2018-Skt-II dated 17.04.2020 duly communicated by the Ministry of Human Resource Department, Department of Higher Education (Language Division) vide Office Memorandum No.4-4/2018-Skt.II dated 22.04.2020, Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) has been established as Central University and started its functioning as "Shri Lal Bahadur Shastri National Sanskrit University, New Delhi-11016" with effect from 30.04.2020. In this context, the University has issued a Notification vide F.No.1(149)/LBSV/Admn./2019-20/20 dated 30.04.2020 for information of all concerned.





- (b) The PhD shall be awarded to a candidate who, having critically investigated and evaluated an approved topic resulting in an independent and original contribution to knowledge and demonstrated an understanding of and competence in research methods appropriate to the chosen field, has presented and defended a thesis by oral examination to the satisfaction of the examiners.
- (c) The Research Degrees Committee shall ensure that all examinations are conducted and the recommendations of the examiners are presented wholly in accordance with the Vidyapeetha's Bye-Laws and relevant UGC Regulations as amended from time to time. In any instance where the Research Degrees Committee is made aware of a failure to Vidyapeetha's Bye-Laws or UGC Regulations comply with all the procedures of the examination process, including submission of the external Examiners' reports and conduct of the oral examination, it may declare the examination null and void, and advise the Vice-Chancellor to appoint new examiners. The Research Degrees Committee will have the right to impose sanctions on supervisors if a serious breach of Bye-Laws/Regulations or procedures occurs.
- (d) After considering the reports of external examiners & viva-voce report, the RDC will recommend for award of Ph.D. degree. On the recommendation of the RDC, Provisional Certificate for award of Ph.D. Degree be issued after due approval of the Vice-Chancellor.
- (e) The Controller of Examination shall function as Member Secretary of the RDC and Assistant Registrar (Examination) may function as Coordinator of the RDC.

Introduction

The Vice-Chancellor Prof. Ramesh Kumar Pandey constituted a Committee to prepare the proposal to promote Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (SLBSRV), at present a Deemed University, into **Central University of Sanskrit** to focus, among the given tasks, on the international dimension of Sanskrit knowledge systems consisting of the following members:-

1. Professor Kapil Kapoor, Chancellor, Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya, Wardha
2. Professor T. V. Kattimani, Vice Chancellor, Indira Gandhi National Tribal University, Amarkantak, Madhya Pradesh

The Committee met more than once in the Office of the Vice-Chancellor.

In the first meeting convened on 10th July, 2017, the Vice-Chancellor informed that the need to establish this Vidyapeetha as **Central Sanskrit University** was discussed in the Academic Council and the Board of Management of the Vidyapeetha and it had subsequently been decided to prepare a formal proposal to this effect for submission to MHRD.

After indepth discussion in the meetings held on 03.08.2017, 22.08.2017, 08.09.2017 & 04.10.2017, the Committee prepared the following report incorporating

the rationale for developing Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (SLBSRV) as Central Sanskrit University and made the recommendations stated below.

An old felt need

The Committee noted that historically a need had been felt for a premier Sanskrit Institution in Delhi. Infact, Akhil Bharatiya Sahitya Sanskrit Sammelan (established by Pandit Madan Mohan Malaviyaji in 1917) at its later meeting held at Calcutta in 1961-62, suggested the establishment of a premier a Sanskrit Institution in the capital city of India on the basis of the recommendation of the Government of India's Sanskrit Commission 1956-57. Accordingly, the Kendriya Sanskrit Vidyapeetha was established in the Academic Session of 1961-62 on the auspicious day of VijayaDashmi under the Chairmanship of Shri Lal Bahadur Shastri Ji, the then Home Minister of India. Later as the Prime Minister of India, Shri Shastri Ji continued to be the Chairman of this institution and was infact, the mentor and guide of this Vidyapeetha till his last breath. After his demise, the Prime Minister Smt. Indira Gandhi became the Chairman of this Vidyapeetha and declared that this institution shall henceforth be known as Shri Lal Bahadur Shastri Kendriya Sanskrit Vidyapeetha, New Delhi.

Vision of a Central Sanskrit University

There has been a vision at least since 18th Century of setting up an Institution of Higher Learning to promote Sanskrit intellectual heritage. In 1791 Jonathan Duncan the representative of the East India Company proposed to the then Governor-General Lord Cornwallis, the establishment of a Sanskrit Institution for the development and preservation of Sanskrit **vangmaya** (entire body of Sanskrit Compositions). Jonathan Duncan had observed that such an institution in the interest of knowledge shall be immensely beneficial for all. (See Appendix 1)

Managing the wealth and range of Sanskrit knowledge

It may be noted that it was in Europe that the Sanskrit studies were pioneered. In fact the Indian Renaissance, that actually took place in Europe, was instrumented by a re-actualisation of Sanskrit learning after the establishment of the first Chair in Sanskrit in Denmark. By 1807 most of the important Universities of Europe had a Chair of Sanskrit and in the nineteen century all the bright Europeans were either Sanskritists or studying and specialising in Sanskrit. Sanskrit, in fact shaped what is known as the contemporary western thoughts. What was called by Europe the discovery of Sanskrit led in Europe to the creation of a new discipline, Historial Linguistic, formation of a new system of ideas, Structuration and the formulation of some of the finest creative minds such as Nietsczhe, Schopenhauer, Ferdinand De-Saussure, Trubetzkoy, Roman Jakobson among other such. They are, as is well known, the precursors of modern western thoughts.

It is known that in South East Asia, Central Asia & East Asia Sanskrit had been employed and studied for almost 2000 years and has left its vast treasure in the form of manuscripts, influence on local languages and in the art and culture of the region.

Efforts for Central Sanskrit University



With the awareness that Sanskrit is the language of, and object of, reverence for all Indians, after independence a serious effort was made on February 28, 1956, when a deputation of the Sanskrit Visva Parisad consisting of the Late N. Chandrasekharalyer, Ex-Judge, Supreme Court, Shri M. Ananatasayanam Ayangar.

Dr. C. Kunhan Raja, Chair Professor for Sanskrit at Teheran says in his booklet (1946). Sanskrit University: A Vision and Mission that "if the languages of India are classified, they fall under three headings: languages of particular regions, of individual communities and the

language of the whole of India. Sanskrit can be styled the All-India language".

Speaker of the Loka Sabha, Sardar K. M. Panikkar and Shri M. Patanjali Sastri, Ex-Chief Justice of India, submitted a Memorandum to the Sanskrit Commission set up by the Government of India **asking for the establishment of an All-India Sanskrit University**, where Sastraic learning would be pursued on intensive traditional lines, together with pertinent modern science.

On February 28, 1956, a deputation of the Samskrta Visva Parisad consisting of the late N. Chandrashekharalyer, Ex-Judge, Supreme Court, Shri M. Ananatasayanam Aiyanger, Speaker of the Loka Sabha, Sardar K. M. Panikkar and Shri M. Patanjali Sastri, Ex-Chief Justice of India, submitted a Memorandum to the Government of India asking for the establishment of an All-India Sanskrit University, where Sastraic learning would be pursued on intensive traditional lines, together with some modern science (**Sanskrit Commission Report pg. no 187**).

It was the considered opinion of the Commission that such University shall tone up the traditional system of Sanskrit Education considerably and bestow prestige and also afford ample opportunities for higher work. It will help the integration of the traditional depth of Sanskrit knowledge and the new critical spirit leading to the dawn of a New Age of Creative Scholarship in Sanskrit.

Effort in Constitution Making

This thrust of the Sanskrit Commission was the inspiration for a powerful amendment proposed on September 12, 1949 at the time of the framing of the Constitution in the Constituent Assembly debate about the official language of the Union by 15 legal luminaries including Chairman of the Draft Committee of the Constitution of India and the Law Minister Dr. B. R. Ambedkar and Mr. Naziruddin Ahmed, to make Sanskrit an official language of the country. To quote the debate, one of the members Mr. Naziruddin Ahmed replying to a question asked by the Hon'ble Member whether Sanskrit should be adopted as the National Language or not, said:

Yes, and for the simple reason that it is impartially difficult to all. Hindi is easy for the Hindi speaking areas, but it is difficult for other areas. I offer you a language which is grandest and the greatest, and it is impartially difficult, equally difficult for all to learn. There should be some impartiality in the selection. If we have to adopt a language it must be grand, great and the best. Then why should we discard the claim of Sanskrit?" **(Constituent Assembly debate on Sanskrit)**

After Independence, the Supreme Court in its 1994 Judgement on the importance of Sanskrit for the country said that "Sanskrit is not only a language it is the vocabulary of our thought and culture";

Teaching of Sanskrit alone as an elective subject can in no way be regarded as against secularism. Because secularism is not anti-thesis of religious devoutness and Sanskrit is the binding force for the different people of the country and is also embodiment of Indian culture and civilisation. Indeed, our Constitution requires giving of fillip to Sanskrit because of what has been stated in Article 351, in which while dealing with the duty of the Union to promote the spread of Hindi, it has been provided that it would draw, whenever necessary or desirable, for its vocabulary, primarily on Sanskrit (Constitution of India, 1950).

The earlier commissions -University Education Commission, (1948) Mudaliar Commission (1952) and Kher Commission (1955) - had also discussed the question of Sanskrit education and pointed out that Sanskrit has enormous potential and offers many opportunities for research

Various State Governments had also appointed Committees to examine different aspects of Sanskrit education and research and what could be done in that direction.

However, regretfully, for all these incessant concerns in the last 70 years, no initiative has taken shape to formulate a course of action on establishment of a Central University of Sanskrit.

Functions of the Proposed Central Sanskrit University

Such Central University of Sanskrit would be the nodal institution for the widely dispersed, immensely rich, multi-level, diverse study and research in Sanskrit all over the world through networking, coordination, maintenance, storage and transfer mechanisms.

Today Sanskrit is being studied and taught, in both the traditional domains and the new domains such as Information Sciences and Computational Technology. Also there is the still incomplete challenging task of transferring the endlessly large corpus of intellectual texts in Sanskrit in practically every discipline into modern Indian languages, Asian languages and European languages to increase their access to new and wider readership and also foreground the awareness about hitherto unexplored mine of scientific and technological knowledge and insights embodied in Sanskrit *granthas* of all domains. It is for the reason that the classical *granthas* are rich repositories of knowledge that in the 19th century two major series were launched to translate such Indian Intellectual texts into the English language in two well-known series-the Harvard Oriental series and the Sacred Books of the East. Translation of 123 intellectual texts of India (**See Appendix- 2**) proved revolutionary as it made the knowledge enshrined in India's knowledge resource languages a common heritage of the world.

That establishment of Central Sanskrit University deserves the highest priority is evident from the fact that as of today more than 148 Universities/Institutions in the west are teaching researching Sanskrit. Besides there are some very prestigious Institutes of Indology and Indian studies in the premier western universities such as Heidelberg Copenhagen, Cambridge University, Oxford, Rome, Italy, Leiden, Oslo etc to count just a few creating a wealth of Sanskrit research that is scattered and is by and large inaccessible to the Indian scholars and students.

In India, too, with its ancient tradition of Sanskrit learning at present there are different kinds of institutions – Ministries/Universities, the Department of Sanskrit, Sanskrit Universities, Vidyapeethas, Pathashalas and Oriental Research Institutes. These have made their own contribution towards re-location of the Indian minds in the inherited thought, building up texts from fragmented manuscripts, by editing and publishing manuscripts, by imparting the language, literature and philosophy in both the traditional and modern modes, besides carrying out relevant research.

All these institutions worldwide have produced enormous amount of work. However, all the work has been done autonomously and there has not been any significant effort to coordinate and consolidate this work. With the result that the wheel has often been reinvented as researchers and scholars carry out their work without access to available research for technological and linguistic reasons and therefore, duly empowered Central University of Sanskrit is needed for networking, consolidation, storage, maintenance, dissemination and participative collaboration. This would enable quantitative and qualitative quantum jump in the quality of Sanskrit research it shall effectively once again make Sanskrit a global language of knowledge access as it has been for atleast two millenia. Let us recall that the world has seen many linguistic empires of Spanish, French, Russian and of course English. All these had been founded on military conquest and had perished once the military-political power weakened. It is the Sanskrit linguistic empire alone that has been founded **not** on the power of arms but on the power of knowledge and ideas. Hence, Sanskrit, ever a donor tradition, therefore, shall once again become the knowledge hub.

Hence, this proposal is being made to establish a Central Sanskrit University at Delhi.

Mode of Establishing the Central Sanskrit University

Ab-Initio formulation and establishment of an institution is not only an expensive and a difficult task but also redundant. There are so many Sanskrit teaching learning institutions, as we have noted above and there are 16 universities devoted to different dimensions of Sanskrit and located in different regions. Evidently a viable solution for the nearly complete absence of synergy among them has not been found. Therefore it is imperative that now this kind of institutional synergy is enabled. It cannot be achieved through an administrative umbrella body. The logical and academically advisable step would be to modulate an existing premier Sanskrit institution into a Central Sanskrit University.

The question is which Institution should be modulated/ developed as Central Sanskrit University? As noted above, it was the Late Shri Lal Bahadur Shastriji, under whose Chairmanship Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha was founded, who had declared that this institution will become the nucleus of Sanskrit research around the world in the characteristic areas of preservation the sastraic tradition, orality, text-building, manuscriptology and consolidation of research around the world.

Shastriji had in fact said on 27.11.1965 that [our translation into English]

"... this Sanskrit Vidyapeetha, a beautiful dream... [which is to be] given an international shape one day... our expectations are many...to make this such a central institution where not only the scholars from India but also from around the world will come and live teaching studying Sanskrit, noting the research that is being done and themselves work in Sanskrit living here... [So that] the Vidyapeetha becomes an ideal institution whose shape in the capital of India would be what naturally it should be of such an institute?"

Therefore, it is the considered opinion of this committee that Lal Bahadur Shastri Vidyapeetha should be turned into a Central Sanskrit University with marked international dimension. This Central Sanskrit University shall then extend and broaden accessibilities and function as the hub of Sanskrit scholarship around the world and in India with the distinct possibility of it's finally evolving, hopefully, into a new Takshashila.

१७९१ ई. में ईस्ट इण्डिया कम्पनी के तत्कालीन रेजीडेंट श्री जोनाथन डंकन ने भारतीयों में अंग्रेज जाति के प्रति सद्भाव उत्पन्न करने तथा संस्कृत वाङ्मय के अभ्युदय, संरक्षण एवं विकास हेतु यहाँ पर एक संस्कृत पाठशाला स्थापित करने का प्रस्ताव किया, जो गवर्नर जनरल लार्ड कार्नवालिस द्वारा स्वीकृत किया गया। श्री डंकन ने प्रस्ताव में इसकी स्थापना से दो मुख्य लाभों की प्राप्ति की ओर संकेत किया था।

१. पहला लाभ अंग्रेज जाति को यह होगा कि यहाँ की हिन्दू जनता यह समझने लगेगी कि उनसे तथा उनके धर्म एवं सिद्धान्तों से जितना स्नेह हम करते हैं, उतना स्नेह उन्हें अपने देशी नरेशों से नहीं प्राप्त है। अतः इससे अंग्रेज उनके प्रीतिभाजन बन सकेंगे। यद्यपि बनारस में सदा से व्यक्तिगत पाठशालाओं में अध्ययन-अध्यापन की व्यवस्था रही है, किन्तु जैसी पाठशाला की स्थापना प्रस्तावित की जा रही है, ऐसी पाठशाला यहाँ पहले कभी भी स्थापित नहीं हुई और इसके अभाव में हिन्दू धर्म, कानून, कला एवं विज्ञान सम्बन्धी शास्त्रों का संग्रह एवं उनका ज्ञान प्राप्त करने में बड़ी कठिनाई हो रही है। इसे दूर करने के लिए ऐसी पाठशाला की स्थायी रूप से स्थापना अत्यन्त समीचीन होगी। इससे इस पाठशाला के आचार्यों तथा विद्यार्थियों द्वारा इन क्षेत्रों में विद्यमान ग्रन्थों का संग्रह एवं संशोधन स्वल्प व्यय में ही हो सकेगा और इस प्रकार से पुरातन महत्त्वपूर्ण विद्या तथा परम्परा से सम्बन्धित ग्रन्थों का एक ऐसा पुस्तकालय स्थापित होगा, जो सम्प्रति सम्पूर्ण भूमण्डल में विद्यमान नहीं है।
२. दूसरा लाभ इसकी स्थापना के कारण भारतवासियों के हृदय पर होने वाले तात्कालिक प्रभाव से ही ज्ञात हो सकेगा। भविष्य में यहाँ शासन करने वाले अंग्रेज ही इस परिणाम से अधिक लाभान्वित होंगे। हिन्दूविधि की सुरक्षा तथा क्रमबद्धता को अक्षुण्ण रखने का कार्य इससे सम्भव हो सकेगा और हिन्दूव्यवस्था के अनुसार विवादों का सुचारु निर्णय करने में अंग्रेज न्यायाधीशों को सहायता पहुँचाने वाले योग्य व्यक्तियों का इससे निर्माण हो सकेगा।

Hon'ble Sir,

I am writing this to you with a request to consider the proposal of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (SLBSRSV), New Delhi for its conversion from Deemed to be University to Central University. I would like to brief you about the genesis of SLBSRSV, its activities and achievements. SLBSRSV had been established by the Ministry of Human Resource Development, Govt. of India to preserve Shastraic tradition of knowledge, higher learning, interpretation of Shastras, intensive training to teachers in modern as well as Shastraic lore and to establish relevance of Shastras to the problems in the modern context.

Late Shri Lal Bahadur Shastri Ji was the founder President of the Akhil Bharatiya Sanskrit Vidyapeetha Society on whose idea this institution emerged. On 2nd October, 1966, it was renamed as Shri Lal Bahadur Shastri Kendriya Sanskrit Vidyapeetha. Subsequently, a separate society was formed and registered by the Ministry of Human Resource Development, Govt. of India as a sponsoring society for this Institution. The Vidyapeetha was declared as Institution Deemed to be University in 1987 and became fully functional with effect from 1st November, 1991.

The Vidyapeetha has five faculties: Faculty of Veda-Vedanga, Faculty of Darshan, Faculty of Sahitya and Sanskriti, Faculty of Adhunik Vidya and Faculty of Education. The first four faculties facilitate the study of shastraic knowledge and teaching facilities with a view to obtaining degrees of three-year courses of Shastri, Shastri (Hons) and the two-year course of Acharya in different disciplines of Traditional Shastras. All modern subjects are being taught in the Faculty of Adhunik Vidya. The faculty of Education provides teaching facilities for completion of two years teacher-training course called Shiksha Shastri (B.Ed.) and two years course for advanced study in Shiksha Shastra called Shikshacharya (M.Ed.).

The research scholars, who are keen on pursuing research work in various branches of Shastric learning, can join any of the above mentioned faculties as per their specialization through entrance test organized at all India level. There is an independent department of Research & Publication in the Vidyapeetha that collects, preserves and brings out historical publications authored by reputed scholars of the country. It also brings out a research journal **Shodha-Prabha and Vidyapeethavarta**, which carries its own distinction. Since the session 1994-95, the Vidyapeetha has been successfully organizing Vocational courses in Sanskrit, Hindi, and Computer Applications along with the Shastri courses of study. Besides, the Vidyapeetha also offers different part-time courses.

The Vidyapeetha has been accredited with grade "A+" by the National Assessment and Accreditation Council, Bangalore for a period of five years i.e. upto June, 2020.

Over the years, it has grown in its scope of academic activities which includes Sanskrit Teacher's Training Program, Teaching & Research in emerging areas like Astrology, Vastu and other multi-disciplinary fields. Establishment of Centre for Women's Studies and a Computer Centre. The Choice-Based Credit System has been introduced by the Vidyapeetha. The Vidyapeetha had also signed a MOU with the INFLIBNET to join its Shodh Ganga Programme. Under this project, Ph.D thesis of the Vidyapeetha have been uploaded on the Shodh-Ganga and INFLIBNET portal. A project under EPG Pathshala for preparation of Post-Graduate Programme of Sanskrit for PG Students was sanctioned by the UGC. Under the EPG Pathshala, 640 modules have been prepared by the scholar of repute and uploaded on "Swayam Portal" for general public.

Recently, the Vidyapeetha has been designated as Teaching Learning Centre (TLC) under the Scheme of Pandit Madan Mohan Malviya National Mission on Teachers and Teaching by the Ministry of HRD. This centre will help in designing and organizing specified programmes with emphasis on competence building so as to enable the participants to address the needs of education system at local, national and global level. In the coming years, the Vidyapeetha is poised to start programs in the areas of Yogic Studies, Indian Comparative Language & Literature, Comparative Religion & Philosophy, Management Education based on Indian Ethos & Cultural Values, Social Inclusion and Exclusive Policy.

The Vidyapeetha has its own campus spread in about 10.65 acres of land at New Delhi and comprises the Academic block, the Library Block, Guest House, Staff quarters, VC's Bungalow, Vedhshala and Hostel housing for about 100 students.

You will be happy to know that the Vidyapeetha has been striving hard not only to fulfill the dreams of its founder Shri Lal Bahadur Shastri Ji but also initiated efforts to establish it as a Central University of Sanskrit in India. In this regard, the Board of Management while accepting the recommendations of the Academic Council resolved (vide its resolution No.16.4 dated 07.04.2017) that a comprehensive proposal to establish Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi as a Central Sanskrit University be prepared by the Vidyapeetha.

Accordingly, a Committee was constituted by the Vice-Chancellor to prepare the proposal to promote Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi at present a Deemed to be University into Central University of Sanskrit.

The Committee finalized its report on 04.10.2017 and gave its considered opinion that Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha should be turned into a Central Sanskrit University with marked international dimension. This Central Sanskrit University shall then extend and broaden accessibilities and function as the hub of Sanskrit scholarship around the world and in India. (with the distinct possibility of its finally evolving, hopefully, into a new Takshashila) The operative part of the recommendations of the Committee is quoted below:-

"Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University), New Delhi should be promoted and institutionalised as Central Sanskrit University located in the capital city of the country.

The matter relating to establishment of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi as a Central University was considered by the Academic Council and the Board of Management at its 8th and 17th meetings held on 24.10.2017 and 09.11.2017 respectively. I shall be grateful if you could kindly consider the report of the Expert Committee dated 04.10.2017 for establishment of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University), New Delhi as Central University in the capital city of the country at the earliest.

I look forward to your kind cooperation and appropriate direction in this regard.

In accordance with Clause 301(b) of the Central Sanskrit Universities Act, 2020 (No. 5 of 2020) dated 25th March, 2020 as enacted by the Parliament and assented to by the President of India and duly published in the Gazette of India by the Ministry of Law & Justice, Govt. Of India, Legislative department, Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) has been established as Central University named as Shri Lal Bahadur Shastri National Sanskrit University. Consequently, in pursuance thereof, the Ministry of Human Resource Development (Department of Higher Education), Govt. of India vide notification dated 17th April 2020 published in Official Gazette has appointed the 30th day of April, 2020 as the date on which the provisions of the Central Sanskrit Universities Act, 2020 shall come into force. As such, Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) shall start functioning as Shri Lal Bahadur Shastri National Sanskrit University- "श्री लाल बहादुर शास्त्री राष्ट्रीय संस्कृत विश्वविद्यालय" under the above said Act with effect from 30.04.2020.

Accordingly, in the first instance it will be required to make necessary fundamental changes/amendments in the existing arrangements of the SLBSRS Vidyapeetha by the concerned Departments/Units Sections as under:-

- I. Change of name in all the signboards including emblem of the Vidyapeetha by the University Work Department.
- II. Change of name/emblem of the Vidyapeetha in the office seal/letter-heads/file covers, departmental notes etc. by the General Administration -III
- III. Change of name/emblem of the Vidyapeetha in the office letter head/visiting cards/seals of the officers of the Vidyapeetha by the General Administration -III.
- IV. Necessary amendments in the website of the Vidyapeetha and the Identity Cards of the employees by the Computer Centre.
- V. Change of name of the Vidyapeetha in the office records of local authorities such as CPWD, Electricity Board, Jal Board, MCD, DDA, DTC by the University Works Department.
- VI. Change of name in the Registration Certificates, Insurance Certificate etc. in respect of all the Staff Cars of the Vidyapeetha by the General Administration -III.
- VII. Change of name of the Vidyapeetha in the Bank Accounts and office records of the Income Tax Department, Office of the CAG, GeM, Kendriya Bhandar by the Account Section and General Administration - III as the case may be.
- VIII. Change of name in the Lease Deed/Registry of the land of the Vidyapeetha, Legal Documents (name of the respondents in the pending writ petitions), Agreements, MoU etc., by the concerned sections by following the due procedure.

- IX. Change of name of the Vidyapeetha on its membership with AIU, IIC and other project scheme by the Development Section
- X. Change of name on the publications of the Vidyapeetha and other projects like Shodh, Granth, INET, IBNET by the Assistant Librarian and Publication Unit as the case may be.

It has been further provided that any ex-officio member appointed to any of authorities prior to commencement of the Act shall, if such appointment is not in conformity with the provision of this Act, cease to be a member of such authority. Presently, there are total 10 existing members in the Executive Council and all the members were participated in the 1st meeting of EC. Thus, the requirement of fulfilling the prescribed quorum of seven members was completed. In order to get the nominations against the vacant positions of members for EC as per priority, a letter has already been sent to the Ministry in this regard. 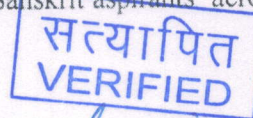
Item No. 1.3

The Executive Council apprised that Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha which was initially declared by the Govt. of India as Deemed to be University in 1987 and subsequently became fully functional with effect from 1st November, 1991 and recently, this institution has been converted as Central University by Govt. of India and named as " Shri Lal Bahadur Shastri National Sanskrit University, New Delhi "श्री लाल बहादुर शास्त्री राष्ट्रीय संस्कृत विश्वविद्यालय, नई दिल्ली" w.e.f. 30.04.2020.

The members of the EC appreciated the decision taken by the Govt. of India and extended their thanks to Hon'ble Shri Ram Nath Kovind Ji, His Excellency President of India, Shri Narendra Modi Ji, Hon'ble Prime Minister of India and Dr. Ramesh Pokhriyal Nishank, Hon'ble Minister of Human Resource Development for conversion of this Vidyapeetha as Central University to fulfil the dreams of Sanskrit aspirants and providing a platform for all the researchers. The members desires to give the complete details of the efforts made by the Vidyapeetha in this regard. Accordingly, the Chairperson informed the following:

In order to fulfill the vision and mission of late Lal Bahadur Shastri ji former Hon'ble Prime Minister of India under whose Chairmanship Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha was founded and had a dream "...to make this institution as a Central institution where not only the scholars from India but also from around the world will come and live teaching studying Sanskrit, noting the research that is being done and themselves work in Sanskrit living here...(So that)...the Vidyapeetha becomes an ideal institution whose shape in the capital of India would be what naturally it should be of such an institute"... and to meet the long pending demands of the Sanskrit aspirants acrossed the country and need of

providing a platform to the National and International Sanskrit scholars, it was felt that there should be a Central Sanskrit University as established by the Govt. of India in other languages in the country. Accordingly, the issue of conversion of Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha, New Delhi as Central University was placed before the Academic Council at its 7th meeting held on 03.04.2017 for consideration. The Academic Council after detailed discussion resolved to authorise the Vice-Chancellor to constitute a High Level Committee to examine the issue and prepare a report related to conversion of the Vidyapeetha as Central University. The recommendations of the Academic Council were approved by the Board of Management vide Resolution No.16.4 (III) dated 07.04.2017 with a direction to prepare and submit a comprehensive proposal to the Ministry of Human Resource Development, Govt. of India for consideration.

In view of the above, the Vice-Chancellor constituted a Committee consisting of the following members for the purpose:-

1. Professor Kapil Kapoor, Chancellor, Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya, Wardha.
2. Professor T.V Kattimani, Vice-Chancellor, Indira Gandhi National Tribal University, Amarkantak, Madhya Pradesh.
3. Professor C.S. Radha Krishnan, Former HoD, Department of Sanskrit, Pondicherry University, Pondicherry.
4. Professor Vasant K.M Bhatt, Former Director & HoD Sanskrit, Gujarat University, Ahmedabad.
5. Professor Santosh Kumar Shukla, Special Centre for Sanskrit Studies, JNU, New Delhi

In view of the mandate given to the Committee, the Committee met on 10.07.2017, 03.08.2017, 22.08.2017 and 08.09.2017 and after indepth discussion and deliberations submitted its report on 04.10.2017 with the following recommendations:

"Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha should be promoted and institutionalised as Central Sanskrit University located in the capital city of the country."

Accordingly, as per the decision of BoM, the Vice-Chancellor met the Hon'ble Minister of HRD and presented the report of the Committee on 27.12.2017. The then Hon'ble Minister of HRD agreed in principle on the recommendations made by the Committee. The Language Division of the Ministry of HRD directed the Vidyapeetha to prepare a draft Cabinet Note and Act for conversion as Central University vide letter dated 14.08.2018. The draft Cabinet Note and draft Bye-Laws (Act & Statutes) of the Central University was submitted to the Ministry of HRD on 20.08.2018.

Meantime, after general election, Dr. Ramesh Pokhriyal Nishank took over the charge as Minister of HRD, Govt. of India and directed the concerned Department of the Ministry to take up the issue under 100 days Action Plan which was assigned by the Hon'ble Prime Minister of India to all the Ministries.

Of India, Legislative Department followed by the Gazette Notification F.No.4-4/2018-Skt-II dated 17.04.2020 duly communicated by the Ministry of Human Resource Department, Department of Higher Education (Language Division) vide Office Memorandum No.4-4/2018-Skt.II dated 22.04.2020, Shri Lal Bahadur Shastri Rashtriya Sanskrit Vidyapeetha (Deemed to be University) has been established as Central University and started its functioning as "Shri Lal Bahadur Shastri National Sanskrit University, New Delhi-110016" with effect from 30.04.2020. 
