Pursuant to the letter No. 8-46/2021-L.II dated 15.11.2021 of the Government of India, Ministry of Education, Department of Higher Education, Language Division, a Committee named as 'Bharatiya Bhasha Samiti' has been constituted to explore and recommend a pathway for holistic, multi-disciplinary growth for promotion of Indian Languages as envisaged in the National Education Policy-2020 and advise the Ministry on all matters pertaining to revitalization of existing language teaching and research and its extension in various institutions in the country.

Terms & Conditions of engagement:

- **Term of Appointment:** The engagement will be purely temporary and will continue only till the services are required by the Bharatiya Bhasha Samiti. The Senior Consultant/Consultant will be initially engaged for a period of three months. The term is extendable by a similar period, subject to satisfactory performance and requirement.
- **Remuneration:** A fixed remuneration as mentioned above shall be admissible. The remuneration amount shall remain constant throughout the term of the contract. There shall be no annual increment/percentage increase during the contract period.

- **Leave of absence:** Paid leave of absence may be allowed at the rate of 1 day for each completed month of service. In addition, two Restricted Holidays are allowed as per Central Govt. Rules. Accumulation of leave beyond a calendar year may not be allowed.
- The Senior Consultant/Consultant shall be ineligible for any other benefits available to regular University employees. She/he will have no claim for regularisation/seniority on the basis of this engagement.
- The Bharatiya Bhasha Samiti reserves the right to terminate the engagement at any time, even before the stipulated time. The consultant shall be required to perform the duties as assigned by the Chairman from time to time during the period of engagement. The complete details of the duties, etc., will be communicated separately along with the offer of engagement.
- The Bharatiya Bhasha Samiti reserves the right to withdraw this notification at any point of time.
